

With reference to the various notices issued (as mentioned above) regarding submission of the pending documents in respect of the students admitted in various UG/PG courses of UTDs/Affiliated Institutes/Colleges in AY 2024-25; in this regard it is informed that 18 students of UTDs and 98 students of affiliated Institutes/Colleges failed to submit the documents exhibiting their eligibility to pursue the said course e.g. Marksheets photocopy of 10<sup>th</sup>/12<sup>th</sup>/Diploma/UG/PG in the prescribed time period i.e upto 31.01.2025. The list of these students of UTDs/affiliated Institutes along with the detail of pending documents is attached as annexure "A".

Keeping in view the future of students, a final opportunity of 07 days from the issuance of this notice is hereby given to these students to submit the documents exhibiting their eligibility with a late fee of Rs. 1000/- per student; there after the students who failed to submit the said documents within these 07 days, their admission will stands automatically cancelled and no further notification will be released by this Branch and no communication in this regard will be entertained.

Further, the students whose only Migration Certificate remains to submit for register them with the University may submit the same as per the schedule already notified vide notice mentioned at reference point 4. All concerned are informed for the compliance of the same.
