### Notes:

1. If the number of teaching days falls below 180 days / 1200 hours (i.e., 90 days / 600 hours per semester) during the academic year due to any unforeseen reasons, the Principal/Director/Head of Department shall ensure that the loss is compensated by arranging extra classes.
2. The detailed schedule of theory and practical examinations, training, projects, thesis, and dissertations, etc., will be issued by the concerned Department/Branch.
3. The schedule of co-curricular and extra-curricular activities will be issued by the Dean Student Welfare (DSW) without affecting the teaching hours.
4. The reports of Student Feedback and Academic Audit, along with analysis and action taken, shall be submitted to the Director, IQAC by the concerned Heads of Institutes/Chairpersons within ten days of the conduct of these activities. A detailed notification in this regard will be issued by the Director, IQAC.

5. Registration of new students and re-registration of existing students, including detained/struck-off students, is mandatory and shall be ensured by the concerned Heads of Institutes/Chairpersons through the Registration and Affiliation Branch.
6. **It is hereby clarified that it is the sole responsibility and liability of the students to maintain the minimum attendance as per the University rules. Students and their parents are advised to regularly obtain updates regarding attendance from the respective class teachers. After the completion of the academic session, no claim by any student regarding attendance will be entertained by the University.**
7. This Academic Calendar is subject to revision as per the guidelines/instructions issued by the State Government, UGC, or AICTE from time to time.
