➤ **GENERAL INSTRUCTIONS:**

All the candidates are advised to read and follow the instructions before reporting in the counseling:

1. The candidates must fulfill the eligibility criteria of the course:
Eligibility Criteria:
(B.Sc. / B.Sc. (Hons.) with 50% marks in aggregate (45% for SC/ST candidates of Haryana only) with Physics as regular subject at graduation level from a recognized Univ./Institute)
2. The candidates are required to keep their original certificates/documents/ testimonials with him/her at the time of Manual / Institute Level counseling for verification.
3. Candidate must have to attend the counseling physically and also to present themselves in person before the admission committee for the allotment of seat. **Physical attendance of the candidate at the counseling is mandatory.**
4. Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.
5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.
6. Admissions must be within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy. (Please refer University Information Brochure 2025-26 and Seat Matrix for UG/PG (except B.Tech) for Admissions 2025-26 notified vide number 10/10/2025/Acad-2265 dated 23.06.2025..)
7. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through PPP (Parivar Pehchaan Patra) as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. **All candidates seeking admission should be advised to get updated and verified their PPP ID.**
8. Candidates have to deposit the Admission Fee amount Rs36292/-. It is mandatory for the candidate to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed.
9. Admission Fee can be deposited in the form of Demand Draft (drawn in favour of "Registrar J.C. Bose UST, YMCA Faridabad") **on the spot** on offering the seat for admission. Payment can also be made by Debit/Credit card with applicable charges. **Cash will not be accepted in any case.** For more details, refer the University Information Brochure 2024-25 available on the University Website.

- **HOGC/ROHC Candidates:**
 - Student claiming HOGC Category should be passed their 12th from the School situated in Haryana or they should possess the Domicile Residence Certificate of Haryana State.
 - Student claiming ROHC Category should be passed from the school situated Outside Haryana or they should possess the Domicile Residence Certificate of State other than Haryana.
- **SGC (Single Girl Child) Candidates:**
 - Student claiming SGC Category should be passed their 12th from the School situated in Haryana or they should possess the Domicile Residence Certificate of Haryana State.
 - The eligible Single Girl Child required to submit an affidavit on stamp paper worth Rs. 20/- duly attested by 1st Class Magistrate, to be obtained from the parents of the girl child declaring therein that the girl child is only a single child of their family not having any brother/sister.
- **Abandoned/Surrendered/Orphan children:**
 - Domicile Residence Certificate of Haryana State (if 10+2 is passed from outside Haryana State)
 - Certificate issued by the Competent Authority/ Body i.e. Concerned District Programme Officer
 - **For Orphan Children Category:** Income Certificate issued by ADC-cum-DCRIO (Additional Deputy Commissioner- cum-District Citizen Resources Information Officer) if applicable (Annexure-XI) (Income verified from PPP) having the family income (including guardian, if any) less than Rs.2.00 Lakh Per Annum from all sources.
- **KM/TFW/PH/ESM/FF Candidates, (if applicable)**
 - For TFW "Annual Family Income certificate" of latest financial year issued by the Competent Authority.


