The above R&D project was sanctioned to Dr. Sanjeev Goyal, Associate Professor with a budget outlay of Rs. 14,00,000/- during the year 2021-22 for the duration of 3 years. 1st year grant amounting to Rs. 7,92,000/- was released to your University on 19.01.2022. As per U.C submitted by your institute at the end of 1st year unspent funds at the end of 1st year of Rs. 5,65,080/- were allowed to be carried forward to 2nd year and Interest accrued at the end of 1st year i.e. Rs. 23850/- were also adjusted. So, total amount of Rs. 5,88,930/- was available during the 2nd year with the Institute.

To review the 2nd year's progress of the project, the meeting of expert group was held on 03.01.2025. PI made the presentation of the work done so far. The progress was found as per timeline of the project. Budget demand for 3rd year for this project is Rs. 1,20,000/- whereas as per the Utilization Certificate submitted by the PI, your Institute already had unspent amount of Rs. 4,87,198/- at the end of 2nd year. So, expenditure for the 3rd year may be met out from the unspent amount lying with your Institute. This unspent amount was allowed to be carried forward to the 3rd year vide this office letters issued vide No. HSCSIT/R&D/2025/260-261 dated 04.02.2025.

You are requested to ensure that the above R&D project may be carried out as per the terms & conditions of the scheme, project work must result in some publications in the SCI journals, each publication must acknowledge HSCSIT grant number proper accounts are maintained in the project, utilization certificates are provided to this office regularly and schedule of the project is strictly adhered to by the PI. The PI will have to submit half yearly and final progress report to this office in the duration of the project.
