# OUR INSPIRATION

## ACHARYA JAGADISH CHANDRA BOSE

(30<sup>th</sup> NOVEMBER 1858 – 23<sup>rd</sup> NOVEMBER 1937)



Shri Jagadish Chandra Bose was a pioneer scientist who investigated radio and microwave optics. He was a polymath, physicist, botanist, biologist, biophysicist and archaeologist. He made significant contributions to plant science, and laid the foundations of experimental science in India. Even a crater on the moon has been named in his honour.

He was the first person to prove that plants also have the ability to feel pain and affection. Jagadish Chandra Bose was an Indian polymath whose research has extensively contributed to the fields of Botany, Physics and Radio Science. He is credited to have laid the foundations of experimental science in India and was a pioneer in the area of microwave optics technology. He designated a galena receiver which was amongst the earlier examples of a lead sulphide photo conducting device. A polymath, Jagadish Chandra Bose left an indelible mark in several fields of study.

He invented the Crescograph for measuring the growth in plants using a series of clockwork gears. He is also credited with the invention of the first wireless detection device; an invention he never tried to get patented himself. He was made companion of the order of the Indian Empire in 1903 and Companion of the Order of the Star of India in 1912 in recognition of his contributions to Science. Jagadish Chandra was acknowledged by IEEE, USA as one of the pioneers in the discovery of radio.

Earlier, known as YMCA Institute of Engineering, Faridabad, was founded in the year 1969 as a Joint Venture of Government of Haryana and National Council of YMCAs of India with active assistance from overseas agencies of West Germany to produce highly practical oriented personnel in specialized fields of engineering to meet specific technical manpower requirement of industries.

The University is well known for its track record of employment of the pass out students since its inception. The University has been recognized at various levels by the agencies including UGC, AICTE, NAAC, NBA and NIRF. The University offers B.Tech and M.Tech programs in core and specialized engineering disciplines. ## ABOUT THE CHANCELLOR



### **SH. BANDARU DATTATRAYA** HON'BLE GOVERNOR OF HARYANA

Popularly known as People's Leader, Sh. Bandaru Dattatreya is the 18<sup>th</sup> Governor of Haryana. He was sworn in as the Governor of Haryana on July 15, 2021.

Sh. Dattatreya was born on 12 June 1947 to Bandaru Anjaiah and Eswaramma at the city of Hyderabad in Telangana State. He received B.Sc degree from Osmania University.

He has been elected as a member of Parliament for 10<sup>th</sup>, 12<sup>th</sup>, 13<sup>th</sup> Lok Sabha (1991-2004) and 16<sup>th</sup> Lok Sabha from Secunderabad Lok Sabha Constituency. Sh. Dattatreya was Union Minister of State for Labour and Employment (2014-2017) in the NDA Government headed by Prime Minister Sh. Narendra Modi and was the lone minister from the State of Telangana.

Earlier, Sh. Dattatreya has also been a part of the Prime Minister Sh. Atal Bihari Vajpayee's cabinet between 1999 and 2004 and held several important positions in the NDA Cabinet. He served as Union Minister of State for Urban Development and Poverty Alleviation and Union Minister of State Ministry for Railways during the Government led by late Prime Minister Sh. Atal Bihari Vajpayee.

Sh. Dattatreya's social and political career started in 1965 when he joined Rashtriya Swayamsevak Sangh (RSS). He worked as Parcharak from 1968 to 1989. He was State Joint Secretary of Loka Sangarsha Samiti (Jayaprakash Narayana Movement) during Emergency period. He joined the BJP in 1980 and worked as the Secretary for its Andhra Pradesh unit. He was appointed General Secretary from 1981 to 1989, President of the Adhra Pradesh unit between 1996 and 1998 and the National Vice-President of BJP in 2013-2014. In September 2019, he was made the Governor of Himachal Pradesh and in July 2021, he became the Governor of Haryana.

**#As per NEP 2020 (National Education Policy 2020) following details should be noted by all applicants:**

**UG Certificate:** Students who opt to exit after completion of the first year will be awarded a UG certificate if, in addition, they complete one vocational course of 4 credits during the summer vacation of the first year. These students are allowed to re-enter the degree program within three years and complete the degree program within the stipulated maximum period of seven years.

**UG Diploma:** Students who opt to exit after completion of the 2<sup>nd</sup> year will be awarded the UG diploma if, in addition, they complete one vocational course of 4 credits during the summer vacation of the second year. These students are allowed to re-enter within a period of three years and complete the degree program within the maximum period of seven years.

**3-year UG Degree:** Students who wish to undergo a 3-year UG program will be awarded UG Degree in the Major discipline after successful completion of three years with the minimum credit requirements.

**4-year UG Degree (Honours):** A four-year UG Honours degree in the major discipline will be awarded to those who complete a 4-year degree program with the minimum credit requirements.

**4-year UG Degree (Honours with Research):** Students who secure 75% marks and above in the first six semesters and wish to undertake research at the undergraduate level can choose a research stream in the fourth year. They should do a research project or dissertation under the guidance of a faculty member of the University/College. The research project/dissertation will be in the major discipline with the minimum credit requirements.

# HOSTEL FACILITY



The University provides hostel facility for girl students of the University, which is located in University campus separately. The boys hostel was demolished and will be re-constructed again, so the Boys Hostel is not available. While providing an opportunity of campus living, Girls Hostel looks forward to residents to shoulder and maintain the best traditions of the University as a whole. There are five wings in Girls Hostel: 1. Kasturba Hall, 2. Sarojini Hall, 3. Mother Teresa Hall, 4. Kalpana Chawla Hall, 5. A. Lalitha Hall. There are dedicated staff members who cater to the needs of the hostellers 24x7. The staff includes Resident Attendant, Guards, Sweepers and Data Entry Operator. Strict rules have been formulated to maintain discipline and hygiene in the hostel premises. Prohibition of ragging is the major priority of the authorities. The hostel is equipped with major facilities such as Reading room with newspapers and magazines, common rooms with LED TVs, high speed Wi-Fi, Water coolers fitted with RO, CCTV cameras and security guards. The hostel provides indoor and outdoor games for recreation & entertainment of the residents within hostel premises. Visitor room is available at the entry of Girls' Hostel for the relatives of the students to meet them. Guest room is also available in Girls' Hostel for female relatives of students. Girls' Hostel will be allotted on first come first basis.

## ● MESS FACILITY

The hostel mess which is run on contract basis provides hygienic food and water with clean utensils and proper furniture for the hostellers to dine. Police verification and medical check-up of the mess workers is done to ensure the safety and health of the students. Periodic inspection is done by the Wardens and Students' Representatives to maintain the standards and quality of the food items. Facility of shift canteen is also provided to the hostellers at the time of exams.

## ● MESS/HOSTEL RULES:

1. The University Girls' hostel mess is run on contract basis and is supervised by the mess committees. The Convener of the mess committee and its members are nominated from the residents of hostel for a fixed period by the wardens.
2. Ragging in any form in the University/hostel/mess is illegal and banned as per UGC Regulations on curbing the Menace of Ragging in Higher Institutions, 2009 act of Govt. of India. In case of disciplinary action against a student, physical presence/Undertaking of Parents (only) will be valid. Uncles, brothers/sisters/cousins will not be entertained.
3. All the residents are expected to take their meals in the hostel mess.
4. All the residents must carry their hostel I-card to the mess while taking meal, failing which they are first warned and then fined according to hostel rules.
5. Meals will be served only in the dining hall during the hours notified. However, in case of illness, meals can be served in the room on the recommendation of the Medical Officer of the University.
6. Residents are not allowed to go into the cooking area.
7. Cooking in the rooms is strictly prohibited.
8. No resident shall take meals from the mess to which she does not belong. A member is not permitted to take food in place of another member.

9. The timing of meals will ordinary be:

a.	Breakfast	07.30am to 09.30am
b.	Lunch	12:30pm to 02:15pm
c.	Dinner	08:00pm to 09.30pm

These timings are subject to changes with the consent of CHW / ACHW.

10. Under no circumstances, members are allowed to take cups, saucers, tumblers and other utensils of the hostel mess to their rooms/lawns outside.

11. Students are expected to maintain perfect discipline and order in the dining halls during dining hours. They are not allowed to enter the kitchen and help themselves. If extra food is required, they must ask the concerned person serving extras. All diners are expected to wear decent dresses in the dining halls.

12. Residents of the hostels have to pay the monthly mess bills upto 12<sup>th</sup> of every month failing which the fine of Rs.10/- per day will be charged. No rebate will be given to the defaulters.

13. Students are not allowed in the mess to take meals in shorts or exposed legs.

14. The residents of the hostel have to submit the hostel and mess charges in form of Demand Draft in CHW office at the start of the session.

15. "No Dues Certificate" will be issued from the hostel only to those students who have cleared all the dues to the hostel. The Chief Warden will report to the Registrar the names of the defaulters of the hostel dues for further action.

16. Every student who is residing in Girls' Hostel is required to pay mess bill of minimum 25 days.

17. After examination before leaving the hostel, the residents should submit the photocopy of "No Dues Slip" signed by hostel attendant & hostel I-card to their respective warden. The slip is checked before allotting the hostel in next session.

18. No drugs/alcohol/tobacco products will be allowed in Hostel premises. Upon finding such taboo objects, very strict disciplinary action will be taken against the involved students.

19. Student cannot misbehave with any hostel staff. Such action will be labelled under misconduct and indiscipline. If she or her guardians have any complaints, they should submit it in writing to the CHW/ACHW for further action.

20. The procedure for taking permission to take part in extra-curricular activities is as follows:-

- The students should submit request application to Hostel Warden. Application must be signed by concerned Authority (Chairperson or DSW).
- The Warden of respective hostel clearly writes either it is recommended or not recommended.
- The ACHW (Girls) will send application to the Proctor/Chief Warden of the University for the Proper Security of the participating students.
- After the allowed time, the respective warden will ensure that either all the students have returned to the hostel or not.



## ● **HOSTEL CHARGES**

1. Girl's Hostel will be allotted to all the University Girls subject to availability. Hostel will be allotted on first come first serve basis. Hostel charges of Rs.19,300/- to be deposited in form of Demand Draft in favour of "**Registrar, J.C. Bose UST, YMCA, Faridabad**" payable at Faridabad are as per following:-

3. Fee refunds will be made in accordance with hostel regulations in the event of withdrawing from a hostel seat.

# FEE RULES FOR SUBMISSION OF SEMESTER FEE

## Due Date, Mode of payment & Re-admission:

- The student shall deposit their semester fee within 20 days of the commencement of every semester (Even/Odd) as per the fee schedule issued by the Accounts Branch of the University.
- The student shall pay their semester fee through University ERP Portal under different mode provided on the Portal Credit Card/Debit Card/UPI etc.
- The student will be given 20 days' time from date of issuance of Notice to deposit the fee without fine and further 15 days time to deposit the fee with a late fee fine of Rs. 500/- The students seeking extension in timeline as a special case are required to submit such request through the concerned department stating the reason for late fee, before last date to deposit the fee with fine. However, an increment of Rs. 500/- in addition to last applicable fine will be done for every 15 days in case of students seeking extension in fee deposit timelines keeping in view duration of extension sought.
- The name of the fee defaulter student shall be struck –off from the University rolls if he/she fails to deposit the fee within the notified timelines
- A student whose name has been struck –off from the rolls of the University may be re-admitted in the same semester of current academic session on the payment of all arrears due from him/her along with fine applicable at the time of submission of re-admission request i.e. an increment of Rs. 500/- for every 15 days from the last date to deposit the fee with fine and re-admission fee of Rs. 5000/- Re-admission is allowed before start of examination only of the current session.
- Students whose name stands struck off from University rolls shall not be allowed to appear for end semester examinations.
- Re-admission is also permitted in the same semester in the next academic session on payment of current semester fee & previous due semester fee only with a lump sum fine of Rs. 2500/-and re-admission fee of Rs. 5000/. If the last date to deposit the fee falls on a holiday, next working days shall be treated as the last date of deposit the fee.

## Fee received through Bank Loan or Scholarships

- To avoid any hardship to students who are availing study loan facility from bank, they will be allowed to submit the fees as and when bank releases the same.
- Students belongs to Schedule Caste (SC) category and eligible for PMS scholarship, no fees and funds should be charged except refundable security money at the time of admission. However, an undertaking may be obtained from the such students that they will deposit the fees to university as and when they receive the same in their account through Direct Bank Transfer (DBT). Eligibility of the candidates for PMS Scholarship may get verified from the Scholarship Branch of the University.
- Further, students who are availing or eligible for Post Matric scholarship, they will be allowed to submit the fees as and when scholarship agency releases the same.
- Students who are availing any loan facility to deposit his/her fee, it is mandatory for them take demand letter from the account branch before last date of deposition of semester fee, otherwise applicable fine as per university rules will be charged from the them

- Student whose semester fee received through bank loan is required to update his/her semester fee (within 07 working days) timely and generate the fee receipt accordingly so that his/her name should not put in the fee defaulter list. If a student fails to do so, his/her cases will be put up before the standing fee committee for further approval.
- Students are advised to refer University Website as well as ERP for information related to fee submission. No separate communication will be issued in this regard.

#### **Fee Concession**

- The University provides financial support to the needy students in the form of Soft Loan to avoid financial hardship of students.
- 50% tuition fee Concession is applicable for students in all programs to the Regular Employees of the University and their wards.
- Fee concession for SC/OBC/EWS students and any other category as per Guidelines issued by the State Government from time to time shall be applicable.

## **CANCELLATION OF ADMISSION & REFUND OF FEE**

- The Application Fees deposited by the candidate for online application is non-refundable.
- For all B.Tech programs guidelines of HSTES (admission brochure) /AICTE Approval Process Handbook and AICTE Academic Calendar 2025-26 will be followed. The refund will be processed as per the instructions of HSTES.
- For Refund of all other programs (except B.Tech), guidelines will be notified on the University Website separately.
- Candidate must submit his/her application for withdrawal of Admission / Refund of Fees, by hand in the prescribed format Annexure-XVII, (as mentioned in this Information Brochure) alongwith necessary documents in Academic Branch.



# ATTENDANCE RULES

1. Every student should get at least 75% attendance in aggregate at the end of each semester to be eligible to appear in end semester examinations.
2. Deficiency up to 10% can be condoned by Chairperson/concerned Dean in severe cases on compensatory ground/medical cases i.e. students with 65% or above attendance can be eligible to appear in the semester exam if 10% deficiency is condoned by Chair person/Dean.
3. The student having below 65% attendance is liable to be detained.  
However, the benefit of additional 2% attendance may be given to the students for participation in Activities like; NSS, NCC, Unnat Bharat Abhiyan, Swatch Bharat Abhiyan or any other community services on the recommendation of concerned Incharge / DWS.
4. Detained student will have to repeat the respective academic semester in the next academic session by paying fee/due etc. as applicable.
5. Any student, who is detained due to a shortage of attendance/ or any other reason must apply to join classes 15 days before the start of session, failing which no application to join classes will be entertained.

It is obligatory on the part of Chairpersons/Teacher concerned to announce attendance position of students before commencement of class test 1 and 2. It is emphasized that students are solely responsible for maintaining the requisite attendance as per University rules and obtaining monthly updates from their respective subject teachers. After the completion of classes, the University will not entertain any claims regarding attendance from students or their parents.

**NOTE:-** However, the Parents/Guardians of students are also requested to keep close watch on the attendance position of their son/daughter/ward by enquiring from the concerned Head of Department. No further notice shall be issued in this regard.



# SCHOLARSHIPS & AWARDS

## ● SC AND BC POST MATRIC SCHOLARSHIP

In the scheme of Technical Education Department for students of B. Tech & M. Tech Courses and Scheme of Higher Education Department for students of other courses (BA, BSW, MA, B. Sc, M. Sc. B. Com, BBA, MBA BCA, MCA), benefits are available to SC and BC students whose parents/guardians income from all sources does not exceed Rs.2.50 Lacs per annum. In this scheme tuition fee & other allowances are reimbursable subject to attainment of 75% attendance in each semester and as per instructions issued by state Govt (Haryana) from time to time.

Application Forms for this scholarship are filled in the month of November/December every year online or offline mode as per notice published on the University website or by welfare of Schedule Caste and Backward Classes Department, Chandigarh.

## ● MERIT-CUM-MEANS SCHOLARSHIP

15% of the sanctioned strength of B.Tech./MCA/MBA courses are eligible for grant of Merit-cum-Means Scholarship for B.Tech./MCA/MBA students @ Rs.750/- p.m. The criteria of parent's income will be as per State Govt. Norms for all above scholarships.

Performance and attendance standards shall be as per University Rules or decided by Competent Authority from time to time. (The above Scholarships are for candidates belonging to Haryana or Admitted through Central Counseling only).

## ● FEE ASSISTANCE TO ECONOMICALLY WEAK/NEEDY STUDENTS

The University in association with The MOB (Alumni Association of J.C. Bose University of Science and Technology, YMCA, Faridabad) supports the economically weak/needly students of the University by paying their fee in the form of soft loan from the session 2020-21 onwards. Under this scheme, financial support in the form of soft loan is provided to the students in following cases:-

- Death of a parent/sole earning member of the family.
- Critical illness for self/family member incurring exorbitant cost.
- Loss of job/earning of a parent/sole earning member for a substantial period.
- Any other reason to the satisfaction of the Competent Authority.

The notice for this scholarship is issued in every semester.

## ● VISHWA PRAKASH MISSION

Vishwa Prakash Mission, Faridabad is supporting students by offering scholarship (Merit-Cum-Means) since 2016-17. Notification of scholarship is issued in the month of October-November every year.



## BHARTI AIRTEL FOUNDATION

Bharti Airtel Foundation is offering merit based scholarships to B.Tech & B.Tech Leet girls students from the session 2023-24 onwards.

### Note:

- If a girl student gets the Governor/Chancellor Gold Medal then Chief Minister Gold Medal will be given to the next topper amongst the girl students.
- One student will get only one such prestigious award.
- For Vice-Chancellor Gold Medal, due weightage will be given to academics and co-curricular activities and a criteria for this would be pre-decided by a Committee constituted for the same.

The details of above selected students are displayed on the University website in the secured manner.

## NATIONAL SCHOLARSHIP PORTAL

Some Scholarships are also awarded to the students through National Scholarship Portal (NSP). For these scholarships concerned students have to apply online on NSP to get the scholarship through DBT after verification of their scholarship forms on "NSP by the University. The name of such scholarship are Post Matric Scholarships Scheme for Minorities, Merit Cum Means Scholarship for Professional and Technical Courses CS, Central Sector Scheme of Scholarships for College and University Students, PG Indira Gandhi Scholarship for Single Girl Child, Pragati Scholarship Scheme for Girl Students, Saksham Scholarship Scheme for Specially Abled Students etc.

Few scholarships are also awarded by Government, viz; Prime Minister Special Scholarship Scheme for J&K Students & also various Charitable Bodies/Trust/Industrial Houses viz; RKM Scholarship, Foundation for Excellence, Shri Sultan Chand Trust, New Delhi, Siemens Scholarship, Inspire Scholarship, Guru Harkrishan Educational Society, Chandigarh, and many more Scholarships on the basis of verification of scholarship forms of the concerned students by the University.

Notification for all such scholarships is published in the month of Nov./Dec. every year on University website.



# DISTRIBUTION AND RESERVATION OF SEATS

## ① DISTRIBUTION OF SEATS

## ② ECONOMICALLY WEAKER SECTION (EWS)

Beside the above reservation, the person belonging to Economically Weaker Section (EWS) who are not covered under the existing scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and Backward Classes (Block-B) shall get 10% reservation in admissions. These seats shall be supernumerary in nature. Candidates have to apply separately for EWS scheme. The candidates belonging to EWS category have to submit a certificate as per the Annexure-XIV of the Information Brochure. The issuing authority shall be same as prescribed for issue of resident/income certificates as specified in instruction No. 22/28/2003-3GS-III, dated 30.01.2004.

## ③ EX-SERVICEMEN & FREEDOM FIGHTER

In the event of quota reserved for Physically Handicapped remain unutilized due to non-availability of suitable category of handicapped candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%). Further 3% horizontal reservation is also provided to Ex-servicemen / Freedom Fighters and their dependents by providing reservation within reservation of 1% of general category, 1% out of Scheduled Castes and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided/ Institutes located in Haryana. As far as block allocation in Block-A and Block-B of Backward Classes category is concerned, year-wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in the academic year 2020, the next block i.e. Block of category of Backward Classes will be given seats in the next academic year i.e. 2021 and so on.

## 4 SCHEDULED CASTE

Instructions issued vide Notification No.22/27/2019-1GS-III dated 04.06.2020 by the GS-III Branch of Govt. of Haryana for Haryana Scheduled Castes should be implemented as follow:

"Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any Government educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as numerated in its Annexure.

Where a seat is set aside for candidate from the deprived Scheduled Castes for admission in Government Educational Institution is not filled up in any academic year due to non-availability of candidate of the deprived Scheduled Castes possessing the requisite qualification, the same shall be made available to the candidate of Scheduled Castes." (List of Scheduled Castes and Deprived Scheduled Castes are given in Annexure-XV).

## 5 BACKWARD CLASS

Backward Class certificate (BCA or BCB) as per Annexure-V, if applicable and creamy layer / annual parental income certificate as per No. 491-SW (1)-2021 dated 17 November, 2021. Refer the notification available Annexure-XVIII.

## 6 RESERVATION TO FEMALE CANDIDATE

25 % horizontal reservation in all categories shall be provided for female candidates.

## 7 ONE SUPERNUMERARY SEAT FOR SINGLE GIRL CHILD

The University has taken a decision regarding creation of one supernumerary seat in UGC approved course/ programmes (except AICTE approved programmes viz B.Tech/ BBA/ M.Tech/ MBA/MCA) being run in the University Teaching Departments, for a single girl child of her parents. The admission on this Supernumerary seat in a UGC course will be made on the basis of the merit of entrance test conducted by University or marks of qualifying examination as the case may be as per schedule mentioned in the University prospectus. The eligible single girl child claiming for the Supernumerary seat in a UGC course is required to submit an Affidavit on Stamp Paper worth Rs.20/- duly attested by 1<sup>st</sup> Class Magistrate, to be obtained from the parents of the girl child declaring therein that the girl child is only a single child of their family and not having any brother/sister. If the supernumerary seat in a course remains vacant due to non availability of suitable candidate, it may not be offered to candidate of any other category. The Supernumerary seat shall be offered to only single girl child of Haryana State, provided she is otherwise eligible from all angles.

If there is more than one claimant to the seat under this category, the admission will be made as per the merit list of entrance test or marks of the qualifying examination, as the case may be.

## 8 TUITION FEE WAIVER (TFW) SCHEME

Tuition Fee Waiver scheme (TFW) Scheme shall be applicable to B.Tech, BBA, BCA, MCA, MBA etc. (as applicable) Programs as per the AICTE guidelines given in the latest Approval Process Handbook of AICTE. Under this scheme up to a maximum of 5% seats of approved Intake are available in AICTE approved B. Tech, MCA & MBA programs of the University. Sons/Daughters of parents whose annual income from all sources does not exceed Rs. 8,00,000/- can apply to take admission under this scheme. All other Fees except Tuition Fee shall have to be paid by the beneficiary. A letter in this respect shall be issued by the Competent Authority for admission to each beneficiary student admitted under this scheme and he/ she shall not be allowed to change the Institution/ program under any circumstances. In the event of non-availability of students in this category, the same shall not be given to any other category of candidates.

## 9 HARYANA GOVERNMENT SCHOOL TOPPERS (HGST)

One seat in each branch discipline of B.Tech courses is reserved for topper of 10+2 within sanctioned intake (Science stream of year 2025 having minimum 2nd Division).

## 10 SUPPORT TO ABANDONED, SURRENDERED AND ORPHAN CHILDREN

One seat in all UG/PG/ other programs of UTD of this University will be reserved for Abandoned / Surrender / Orphan Children. The programs which required AICTE Approval, the seat will be filled under EWS Category and if same is lying vacant or no application has been received, then seat will be merged in EWS Category. For other programs except AICTE approval, one seat reserved as supernumerary seat and if remain vacant will not be filled/merged in any other category, as per the provisions of HSTES.

Criteria for admission under this policy:-

- a) Abandoned and Surrendered Children upto the age of 25 years who were admitted to the Child Care Institutions before the age of 05 year (as Abandoned) and before the age of 01 year (as Surrendered) and have completed the age of 18 years while living in Child Care Institution.
- b) Orphan Children, who have lost their parents (both father & mother) and is without biological or adoptive parents or legal guardian or whose legal guardian is not willing to take or capable of taking care of the child and having the family income (including guardian, if any) less than Rs. 2.00 Lakh per annum from all sources.

Both (a) and (b) will be provided Free Higher Education including Technical Education alongwith hostel facilities in the University. However, minimum eligibility criteria of respective courses as per University Information Brochure notified time to time, must be fulfilled by the applicants (**see the Annexure XX for detailed information**).

### Important Instructions for Reserved Category Seats

- The reservation of seats is as per the Reservation Policy of the State Govt. and is subject to any change/ amendment made by the State Govt. from time to time.
- All eligible candidates of reserved categories of Haryana shall be considered first for Haryana General Category seats.
- Haryana Resident certificate should be in format as per Annexure-II.
- Candidates who have passed their qualifying examination from a University/ College/ School situated within the State of Haryana, will be deemed to be Haryana Residents and will not be required to submit certificate of Bona fide Resident of Haryana.
- Candidates claiming reservation under Scheduled Caste category are required to submit the certificate as per Annexure-IV.
- Backward Class (Block 'A' & 'B') candidates have to submit the certificate prescribed as per Annexure-V & Income certificate issued by the authority prescribed for issue of resident/income certificates as specified in instruction No. 22/28/2003-3GS-III, dated 30.01.2004. The BC candidates (Block 'A' & 'B') for benefit of reservation shall also have to furnish an affidavit / undertaking to the effect he/she is not covered under the criteria of creamy layer as per Annexure VI as well as Annexure XVIII of the Information Brochure. The said Affidavit / Undertaking shall be furnished both by the father and mother of the candidate.
- Only those candidates having a permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission under "Differently-abled persons" category Certificate must be obtained from the Chief Medical Officer heading the constituted Medical Board of the concerned District. "Differently-abled" candidates belonging to Haryana are required to submit the certificate as per Annexure -VII.
- Children & grand-children of Freedom Fighters of Haryana who wish to be considered for reservation shall be required to produce certificate as per Annexure -VIII.
- If a candidate is admitted on the basis of claim that he/ she belongs to the State of Haryana but at any subsequent time it is discovered that his/ her claim was false, the student shall be removed from the institution and all fees and other dues paid up to the date of such removal shall be confiscated. The University may take such other action against the student and his / her parents/ guardians, as it may deem proper in the circumstances of any particular case.
- In the event of quota reserved for Physically Handicapped remain unutilized due to non-availability of suitable category of handicapped candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

The students who failed to submit the specified/requisite documents in the prescribed time period, their admission will stand automatically cancelled. All concerned are requested to strictly adhere the above schedule.



# GENERAL INSTRUCTIONS FOR APPLICANT

All candidates are advised to carefully read and follow the instructions before applying for admission and reporting for admission counseling.

1. Before filling out the online application form, candidates are required to carefully read the Information Brochure and the guidelines/instructions available on the University website.
2. Candidates must apply for admission to various programs offered by the University Teaching Departments (UTDs) exclusively through the University Admission Portal <https://jcboseust.ac.in/admissions/2025-26> within schedule timeline. Applications submitted in physical form or through any other means will not be accepted.
3. Candidates can submit a single application form for multiple programs, provided they pay the applicable fee for each program separately.
4. If a candidate wishes to apply under multiple categories (other than Open/General) such as ROHC/HOGC, SC/ST/BC, PH, FF, ESM, TFW, EWS, KM, HGST, etc., for the same program, they may do so within a single application form.
5. The application fee is non-refundable under any circumstances and cannot be carried forward or adjusted for any future admission or selection process.
6. Candidates must verify their eligibility for the respective program and the category under which they intend to apply before submitting their application or accepting admission. If a candidate is found ineligible at any stage, their application or admission will be automatically canceled. Fees once paid will not be refunded in such cases.
7. If a candidate provides false information or suppresses material facts, their application will not be considered for admission. If a candidate is admitted based on such misrepresentation, legal action will be taken as per the law of the land, and their admission shall be canceled in accordance with university rules. Additionally, all fees paid will be forfeited.
8. All information related to admissions, schedules, instructions, merit lists, etc. will be displayed on the University website. No separate call letters, SMS, or emails will be sent. Candidates are advised to regularly visit the University website for the latest updates and important announcements.
9. In the event of any inconsistencies in the rules or the need for clarification, the matter shall be referred to the competent authority for interpretation, and their decision shall be final and binding.
10. Candidates whose final results of the qualifying examination are awaited may also apply for MCA, MBA, M.Tech, MA-JMC, MSW and M.Sc programs (where merit list is prepared based on the University Entrance Test or a valid GATE score). However, they must submit their passing certificate with the required percentage as per the eligibility criteria within the notified schedule. Failure to do so will result in automatic cancellation of admission, and the entire fee paid will be forfeited.
11. No request for a change in the merit list will be entertained based on the submission of any category certificate or other documents after the merit list has been published.
12. Admissions shall be made within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy.
13. The caste, reservation benefits, annual income, and financial benefits granted to candidates shall be based on verified caste/income data fetched through PPP (Parivar Pehchaan Patra) as per the State Government norms. Any unverified PPP data will result in the candidate being considered under the general/open category. All candidates seeking admission are advised to ensure that their PPP ID is updated and verified.

14. The student claiming HOGC (Haryana Open General Category) category should be passed their last qualifying exam from the school/Institute situated in Haryana or He/She possess the Domicile/Regidence Certificate of Haryana State. The student claiming ROHC (Rest of Haryana Category) Category should be passed their last qualifying exam from the school/institute situated outside Haryana or they should possess the Domicile/Regidence Certificate of State other than Haryana.
15. Candidates must attend the counseling physically and present themselves in person before the admission committee for seat allotment. Physical attendance of the candidate at the counseling is mandatory, and no proxy or representative will be allowed.
16. Eligibility of the candidate with respect to program, category etc for the admission is subjected to verification and submission of requisite documents at the time of admission counseling / reporting /document verification.
17. Eligibility of the candidate with respect to the program, category, etc., for admission is subject to verification and submission of the requisite documents at the time of admission counseling, reporting, or document verification.
18. If a candidate reports late for document verification during counseling, he/she will be considered only for the available seats at their turn after the verification of documents.
19. Candidates must deposit the admission fee applicable to the respective program. It is mandatory to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed.
20. Candidates are required to keep their original certificates, documents, and testimonials, along with two sets of self-attested photocopies, at the time of counseling, document verification, and reporting for verification. However, the university will not retain their original certificates or mark sheets.
21. All admitted candidates shall be governed by the Academic Regulations and/or Ordinances as prescribed by the University from time to time.
22. In case any grievance arises on the spot during admission/counseling, the matter shall be addressed by the Dean of the concerned faculty. If the matter is not resolved, it shall be forwarded along with the justification of department to the Admission Grievance Committee of the University through Academic Branch, with a written representation through the proper channel.



# GUIDELINES FOR FILLING THE ONLINE APPLICATION FORM

1. Before filling the Online Application Form, candidates are required to carefully read the Information Brochure, guidelines, and instructions available on the University website. Application forms must be submitted online through the University's website: [www.jcboseust.ac.in/admissions/2025-26](http://www.jcboseust.ac.in/admissions/2025-26) for admission to various courses. Candidates must bring all their original certificates along with two sets of self-attested photocopies at the time of reporting for admission to the University (refer to the "List of Documents").
2. Candidates shall be allowed to appear in the Entrance Test provisionally, subject to the determination of eligibility at a later stage. Merely appearing in the University Entrance Test or clearing it does not confer any right to claim admission to any course.
3. No column should be left blank in the Online Application Form. Write "N.A." against the columns that are not applicable; otherwise, the application will be considered incomplete and is liable to be rejected.
4. If any candidate is found to have provided false information/certificates/documents or has concealed or withheld any relevant information in the Application Form, he/she shall be debarred from admission to the program.
5. If a candidate is admitted based on information that is later found to be incorrect or false, his/her admission will be cancelled, and all fees and other dues paid shall be forfeited. The University may also initiate further action against the candidate and/or their guardian, as deemed appropriate.
6. As per the directions of the Director, Higher Education, Haryana, Panchkula (vide letter No. 18/30-2015 UNP (4) dated 08.03.2017), linking AADHAR ID with the bank account is mandatory for all students seeking admission to the University Teaching Departments/Faculties from the session 2017-18 onwards. Every student must possess an AADHAR Number at the time of admission.

The photograph should be taken against a light-colored background, with clear visibility of the face and ears, and without harsh shadows or reflections (if wearing glasses). Caps, hats, and dark glasses are not allowed; religious headwear is permitted if it does not cover the face. For the signature, sign on white paper with a black ink pen and upload only the scanned signature area.
6. Upload the Category Certificate, Income Certificate, and Bona fide Certificate (if applicable) in the prescribed format.
7. Click on **Submit & Lock Profile**, then **Confirm & Lock**.
8. Select the program you wish to apply for.
9. Fill in academic details (10th, 12th, Graduation) as per the eligibility criteria of the chosen program.
10. Upload the required documents/certificates in the prescribed format.
11. Carefully preview the application and verify all details before final submission.
12. Make requisite payment as applicable program(s) and category through on-line payment Gateway only. **Please note that without successful payment application(s) will not be considered for admissions and once payment is made, application form cannot be edited.**
13. Make the requisite payment as per the selected program(s) and category through the online payment gateway only. Note: Applications without successful payment will not be considered, and the form cannot be edited after payment.
14. Print “**Application Form**” for your future reference
15. To apply for additional programs, please repeat steps 8 onwards.

## GENERAL INSTRUCTIONS FOR UNIVERSITY ENTRANCE TEST

1. Candidates can download their Admit Cards (only for Entrance Test based courses) from the University website before the date of conduct of Entrance Test. In case, due to any reason, a candidate cannot download his/her Admit Card two days before the Entrance Test he/she must contact the Academic Branch (Email: [academics@jcboseust.ac.in](mailto:academics@jcboseust.ac.in)). Such candidates must bring two recent passport size photographs duly attested by a Gazetted Officer or Head of the department/faculty last attended by him/her to obtain duplicate Admit Card, 1-2 days before the Entrance Test. No Admit Card will be issued on the day of Entrance Test.
2. Candidate must bring legibly printed Admit Card and one identify proof like Driving License, Voter Card, Aadhar Card, Passport etc./ at the Examination Centre failing which candidate will not be allowed to enter in the Examination Centre.
3. Candidates must not write or change any entry made in the Admit Card after it has been received by them.
4. Candidates must bring the Admit Card with them at the time of Entrance Test. Without Admit Card the candidates will not be allowed to appear in the Entrance Test.
5. Candidates are advised to sit only at the seat allocated to him/her by the Administrator/Centre Superintendent/Invigilator. At the start of the examination and within first five minutes, candidates are advised to ensure that they have got the correct question paper.
6. Candidates are warned not to carry mobile phone or any type of electronic or communication device. If any candidate is found possessing any such item, he/she will not be allowed to enter in the examination centre. Candidate found possessing mobile phone and any other aiding material/device as mentioned above in the examination room will be treated serious violation and it will amount to cancellation of the candidature.

# ANTI RAGGING GUIDELINES & PREVENTIVE MEASURES

Govt. of India and State Govt. of Haryana have already banned the ragging of newly admitted students in all the Professional Institutions. Stern disciplinary action is taken against the students indulging in the ragging of the students, including expulsion from the University and hostels/mess or fine with a public apology or withholding of scholarships or other benefits, debarring from representation in events, withholding results, suspension of campus recruitment / industrial training and alike. If, the individuals committing or abetting ragging are not/cannot be identified, then collective punishment can be awarded to act as a deterrent. In view of the involvement of some senior students in ragging of 1st year students in some of the Institutions in the previous year, Hon'ble Supreme Court of India has directed the concerned Institutions/Universities to take immediate steps for the prevention of ragging of students. The violation of this law (ban on ragging) is not only punishable by a fine of Rs.50,000/- but also may attract rigorous imprisonment for 3 years. In order to curb the ragging, the University takes various steps such as help from the local administration for keeping vigilance in the Campus, senior students are advised individually and in groups and cooperation of their parents is sought explaining the aspects of punishment for violation of law of ban on ragging, by deputing faculty members at different places in the University premises to check the ragging & to book the defaulters during the day and also at mid night.

## What constitutes ragging:


- a any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- d any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- e exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students;
- f any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- i any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

## Deterrent Measures for Ragging:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/ withdrawing of scholarship/Fellowship and other benefits.
- Debarring from appearing in any test examination or other evaluation process.
- Debarring from representing the institution in any regional, national or international event.
- Suspension/expulsion from the hostel.
- Rustication for periods ranging from 1 to 4 Semesters.
- Expulsion from the university and consequent debarring from admission to any other university/institution.
- Collective punishment where warranted.
- Lodging of FIR.
- Display the names and punishment awarded to offender of ragging on the notice boards.
- Endorse the Migration/Transfer certificates with the remarks and punishment awarded to the person on account of ragging.
- Imposition of Fine of Rs. 50,000/-

# STUDENT CODE OF CONDUCT AND DISCIPLINE

## Student Conduct

Students must follow the rules and regulations of J.C. Bose University of Science and Technology, YMCA, Faridabad, Haryana such as:

- Carry the identity cards and wear it around the neck at all times especially when inside the University campus.
- Students shall exhibit highest order of decency not to deface, disfigure, damage or destroy or cause any loss in any manner to public, private or University properties.
- Possessing, consuming or distributing alcohol, smoking, tobacco, harmful drugs, narcotics, e-cigarettes and gutkas are strictly prohibited.
- Drive safely in the University campus and follow traffic rules.
- Park your vehicle in designated parking spots only.
- Do not park in or impede access to: crosswalks, fire hydrants or fire lanes.
- Do not allow/entertain visitors in the campus without prior permission.
- Maintain dignity, decorum and decency regarding wearing of dresses, gossiping, and behaviors. Respect not only the members of teaching/non-teaching members of the University but also to the fellow students.
- Observe silence and tranquility while walking down the corridors (especially when classes are going on).
- Immediately report any accidents or unsafe behaviors to University authority.
- The students are strictly prohibited from indulging and showing boisterous, disorderly and obnoxious behaviour and staging 'Dharna', taking out procession, slogan shouting, putting up poster/writing on wall and roads etc. in the campus.
- Clustering in the corridors or crowding in front of the offices or the campus roads are to be avoided.
- Students should refrain from the use of mobile phones in the class room, computer centre and other academic areas.
- Students should refrain from environmental damage activities in the University campus like throwing plastics, food items etc.
- Students are expected to exhibit highest order of self-esteem and self-respect and are prohibited from indulging in anti-institutional, anti-national, anti-social, communal, immoral or political expressions and activities within the campus.
- Students are expected not to interact, on behalf of the University, with media representatives or invite media persons on to the campus without the permission of University authorities.
- Students are not permitted to either audio or video record lectures in class rooms or actions of other students, faculty, or staff without prior permission.
- Students are not permitted to provide audio and video clippings of any activity on the campus to media without prior permission.
- Students are expected to use the social media carefully and responsibly. They cannot post derogatory comments about other individuals from the University on the social media or indulging in any such related activities having grave ramifications on the reputation of the University.
- Theft or abuse of University computers and other electronic resources such as computer and electronic communications facilities, electrical gadgets, systems, and services, which includes unauthorized entry, use or tamper University or facilities, private residences of staff/teachers etc. offices, classrooms, computers networks, and other restricted facilities and interference with the work of others, is punishable offence.
- Unauthorized entry of outsiders into the campus as well in hostels is strictly prohibited. Without specific permission of the authorities, students shall not bring outsiders (even parents or family members) to the University premises.
- Verbal or non-verbal conduct such as unfair comments, remarks or jokes, letters, phone calls, SMS or emails, gestures, exhibition of pornography, indecent stares, physical contact, stalking, sounds or displays of a derogatory nature which have the purpose and/or effect of interfering with student's/staff's/faculty's academic performance/living environment will be considered as misbehaviour.
- No Society/ Association or Club shall be formed without the permission of the Vice-Chancellor/Dean Student Welfare.
- Do not convene a meeting or invite a person to address any meeting in the University premises without prior permission of the Dean Student Welfare/Proctor.

## **VIOLATION OF DISCIPLINE OF UNIVERSITY**

- Disruption of teaching, student examination, research or administrative work, curricular/extra-curricular activity or residential life of the members of the University or any act likely to cause such disruption.
- Furnishing false certificates or false information in any manner to the University.
- Damaging or defacing University property/name or the property/vehicles of members of the University or any other property inside or outside the University campus.
- Use of abusive and derogatory slogans or intimidatory language or incitement of hatred and violence or any act calculated to further the same.
- Arousing communal, caste or regional feelings or creating disharmony among students.
- Indulging in acts of physical gambling/e-gambling.
- Causing or colluding in the unauthorized entry of any person into the campus or in the unauthorized occupation of any portion of University premises, including hostels or residence block, by any person.
- Indulging in Ragging
- An assault upon, or intimidation of, or insulting behaviour towards a teacher, officer, employee or student or any other person.
- Eve teasing/inappropriate behaviour towards women/girl students.
- Possession or use of any weapons such as knives, explosives and fire arms or any such material in the University premises.
- Committing forgery, tampering with or misuse of the University documents or records, identification cards, etc.
- Indulging in Smoking
- Use of Alcohol and drugs

## **ACT OF VIOLATION OF DISCIPLINE**

The University would Impose the following penalties if any student of the University found involved in the acts of indiscipline activities:

Sr. No.	Acts
1	All acts of violence and all forms of coercion such as gheraos, sit-in or any variation of the same which disrupt the normal academic and administrative functioning of the university and or any act which incites or leads to violence.
2	Gheraos, laying siege or staging demonstrations around the residence of any member of the University Community or any other form of coercion, intimidation or disturbance of right to privacy of the residents of the campus.
3	Consuming or possessing dangerous drugs/drink or other intoxicants in the university premises
4	Theft or Damaging or defacing, in any form, any property of the university or its student or the property/vehicle of any member of the university community
5	Hunger strikes, Dharnas, group bargaining and any other form of protest by blocking entrance or exit of the university, academic and/or administrative complexes/offices or disrupting the movements of any member of the university community
6	Furnishing false certificates, or false information in any manner to the university.
7	Committing forgery, tampering with the Identity Card or University records, impersonation, misusing University property (Movable or immovable), documents and records, tearing of pages, defacing, burning or any other material.
8	Any act of moral turpitude
9	Use of abusive, defamatory, derogatory or intimidatory language against any member of University Community

Sr. No.	Acts
10	Causing or colluding in the unauthorized entry of any person into the campus or unauthorised occupation of any portion of the University premises by any person
11	Unauthorised occupation of the hostel rooms, unauthorized acquisition and use of University furniture in one's hostel room or elsewhere and accommodating unauthorized guests or other persons in the halls of residence
12	Indulging in acts of gambling (in any form) with in the university premises
13	Disrupting/ blocking normal movement of person(s) or traffic in the premises of University blockade or forceful prevention of any normal movement of traffic, violation of security, safety rules notified by the university
14	Not disclosing one's identity when asked to do so by a faculty member or employee of the university/security personnel
15	Improper behaviour while on tour or excursion
16	Engaging in any attempt at wrongful confinement of any member of the faculty, staff, student or anyone camping inside the campus
17	Any intimidation or insulting behaviour (Physical violence/abuse/man handling) towards a student, staff or faculty member or any other person
18	Entering on a vehicle without valid sticker, pass or permission
19	Not wearing ID card around the neck while in University campus

**Note:**

Any other related issue not covered above will also be addressed.

#### **PROCEDURE OF PROCTORIAL ENQUIRY**

As per this document, University has a Proctorial system where administration of student related matters pertaining to all acts of indiscipline are delegated to the Proctor. He/She is assisted by deputy proctors and assistant proctors. The size of the Proctorial Board is decided by the competent authority.

#### **Receiving and recording the Complaint:**

- (A) A complaint/report received in the Office of Proctor from the Registrar office.
- (B) The complaints are also received by the Proctor office/Security Supervisor directly from students, teachers and non-teaching staff of the University.

After receipt of a complaint it is scrutinized by the Proctor and he/she will set up Proctorial Enquiry Committee of either a one/two/three member(s). Proctorial Enquiry Committee shall conduct an in-depth investigation into the matter. Proctorial enquiry is an internal enquiry of the University and hence, no other person except the committee members are allowed to be present during hearings. The accused or complainant is not allowed to be represented by a third party. Similarly, he/she cannot have an observer during the process of enquiry. The Proctorial Enquiry Committee may impose one or more of following penalties if any student of the University found indulged in above acts of indiscipline activities:

- A Warning
- B Fine up to Rs. 50000/-
- C Imposing of security deposit.
- D Suspension from class for recommended period.
- E Temporary or permanent withdrawal of concessions /aids /stipends / scholarships /fellowship/any other facility, etc.
- F Removal/debarring from placement/training by the university.
- G Permanent or temporary expulsion from hostel.
- H Forfeiture of right to admission to any course in the university/ right to employment in the University in future.
- I Rustication/Expulsion from the University.

The Proctorial Enquiry Committee will submit the final report to Proctor of the University for necessary action. However, the final decision of Vice-Chancellor will be abided to all.

# STUDENTS GRIEVANCE REDRESSAL

J.C. Bose University of Science and Technology, YMCA, Faridabad is committed to provide a safe, trustworthy and harmonious work place to all its stakeholders. The University has an effective mechanism in place to deal with day to day grievances related to students, faculty and staff members. The Grievance Redressal Committee for students has been constituted in the University based on the University Grants Commission (Grievance Redressal) Regulations, 2019.

## STUDENT GRIEVANCE REDRESSAL COMMITTEES (SGRC)

To resolve the issues related to students, SGRC may be constituted at various levels as per UGC Regulations for which Dean Student Welfare (DSW) of the University will act as Nodal Officer for the Student Grievance Redressal Committee of the University.

- **Departmental Student Grievance Redressal Committee (DSGRC)**

A complaint by an aggrieved student relating to the Department or Faculty or Centre of the University shall be addressed to the Departmental Student Grievance Redressal Committee (DSGRC) to be constituted at the level of the Department, Faculty or Centre, as the case may be.

- **Institutional Student Grievance Redressal Committee (ISGRC)**

Where a complaint does not relate to any academic Department, Faculty or Centre of the University, as the case may be, the matter shall be referred to the Institutional Student Grievance Redressal Committee (ISGRC) to be constituted by the Vice Chancellor.

- **University Student Grievance Redressal Committee (USGRC)**

The Vice Chancellor of the University shall constitute such number of University Student Grievance Redressal Committees (USGRCs), as may be required to consider grievances unresolved by one or more CSGRC or DSGRC or ISGRC and each USGRC may take up grievances arising from Colleges/Departments/Institutions, on the basis of the jurisdiction assigned to it by the Vice Chancellor.

## R & D CELL

The Research and Development (R&D) cell of the University plays a pivotal role in fostering innovation, creativity, and intellectual growth among its undergraduate, postgraduate, and doctoral students. This entity serves as a gateway to a realm of intellectual exploration and scholarly advancement. It provides a structured platform for students to delve into research projects aligned with their academic interests, nurturing their potential to become tomorrow's leaders in their respective fields. Through mentorship, resources, and collaborative networks, the R&D cell empowers students to embark on transformative journeys of discovery.

Moreover, the R&D cell serves as a bridge between academia and industry, facilitating knowledge exchange and technological innovation through the signing of Memorandums of Understanding (MOUs). By forging partnerships with external stakeholders, students gain exposure to cutting-edge developments in their field and opportunities for applied research, enhancing their academic experience and employability prospects.

Under the R&D Cell, the University offers Ph.D. programs in various disciplines. The University has adopted the UGC guidelines, allowing candidates to seek admission to Ph.D. programs after completing a 4-year/8-semester Bachelor's degree with Research and having a minimum CGPA of 7.5/10 from the session 2024-2025 through its entrance test. However, the applicants who have qualified and valid GATE/UGC/NET/CSIR (JRF)/SLET/ passed regular M.Phil Program in the related discipline are exempted from entrance.

The following scholarship schemes are available for research:

- (a) University Research Scholarship (URS) of Rs. 25,000/- per month.
- (b) Fellowship/scholarship from outside organizations such as CSIR, UGC, DST, AICTE, etc.
- (c) Fellowships available from IOCL and MOB Alumni Association.

### **In its short span of two years from inception, the R&D cell achieved the following milestones:**

Initiated a total of 30 research collaborations with industry/institutions of international and national repute.

Secured sanction for more than 21 research proposals from various funding agencies.

More than 150 students qualify in various national-level competitive exams such as GATE, CAT, NET, etc., with commendable scores.

8. To prepare the Annual Quality Assurance Report (AQAR).




# INCUBATION CENTRE

The University has established a thriving ecosystem for innovation, centered around JCB-TBI and supported by key initiatives such as the IoT Lab, Co-working Space, and a 3D printing setup for prototyping and testing. This ecosystem fosters the creation and transfer of knowledge. At JCB-TBI, we provide comprehensive support in technical expertise, strategic management, and business mentoring, guided by experienced faculty and industry experts. Several dynamic startups have flourished under our mentorship, including The Tee Point, Galichaa, Extreme Insurance Surveyors, KimTech Innovations Pvt. Ltd, METASAGA Pvt. Ltd, Smart Skill Wave, Nestays, Nano Agro, Skillwhiskill, TilaHeal, and SpiruFit.

To nurture entrepreneurial spirit, we regularly organize seminars, startup events, motivational and technical lectures, workshops, and symposiums on topics such as Ideation, Startups and Entrepreneurship, Intellectual Property Rights (IPR), and Industry-Academia Innovative Practices. Additionally, JCB-TBI actively supports budding entrepreneurs by assisting with fund raising through various initiatives. The University has set up a comprehensive Start-up Entrepreneurship Workshop Program to help our students to understand the deep nuances of business and all its components including market research, business planning, pitching to investors for successful implementation of their start-up business ideas. Incubation Centre has already successfully conducted over 50 programs /competitions / workshops for Innovation and Entrepreneurship and half a dozen programs / workshops on Intellectual Property Rights (IPR) etc.



# DIGITAL LEARNING MANAGEMENT SYSTEM



Unleashing the Learning Avenues through Indigenous Digital LMS

The University has a dedicated web-based Learning Management system named “Digital Learning Management System (DLMS)” which is in-house developed. The key objective of this practice is to host and track online learning. Providing a virtual hub where learners can access course materials, DLMS aims to make contents accessible to remote learners, support blended and flipped learning environments; and provide a central location for learning across the University.

At the student end, the system provides facilities to view the shared content, submit due assignments & tests, track their studying progress and interact with their teachers. The purpose of the practice is to combine the traditional instructor-led approach with online learning to enable learners to have control over their training. DLMS is enabled with features like facility of uploading study material and assignments, live chat, live classes, test facility, continuous assessment, discussion forums etc. and students can access it with their login. The quick links of important platforms like University’s Library e-portal, National Digital Library, SWAYAM, Spoken tutorial, ZOOM, Google Classrooms and other e-platforms have also been integrated in this system.

## J.C. BOSE IOT RESEARCH CENTRE

The University has a state of the art, fully equipped Internet of Things (IoT) lab for students to discover their true potential in IoT technology to design, create, test and implement prototypes for their technology based start-up ideas. The lab has all the latest tools and machines including 3D printers, electronic workbenches, Arduino kits and raspberry pi tools etc.

The University has collaborated with RVC Bangalore for IoT programs and projects. University is also under process to sign an MoU with Defence Services for research and development of IoT based projects.



# UNIVERSITY LIBRARY

The Central Library of the University has been named after the great Indian thinker and leader Pt. Deen Dayal Upadhyay. The Central Library of J.C. Bose University of Science and Technology, YMCA, Faridabad is a modern library meant to fulfil the information needs of students, research scholars, faculty and staff of various departments of the University. The library is situated at ground floor having area of more than 7200 sq.ft. with air-conditioned facility. It is well equipped with modern technologies like e-Library Portal, Remote Access facility, Federated Search, Artificial Intelligence based searching, Mobile App etc. The library is centrally located within easy reach from all the departments, hostels and residential areas. It has two Reading Halls with a total capacity of 200 seats.

It is fully automated with Web Based Library Management System "KOHA". Web OPAC (Online Public Access Catalogue) facility is available to know the availability of books and its position in the library. Library is also equipped with RFID (Radio Frequency Identification) technology. RFID enabled gates are available for security check of documents. Books can be returned round the clock by the users through Book Drop facility. Library is having total collection of more than 91000 books in the stream of Engineering, Technology, Sciences, Management and Humanities. More than 13000 e-journals are being subscribed from the reputed publishers like, Elsevier's Science Direct, Taylor & Francis, IEEE, Springer Link and Nature to promote the research activities in the University. More than 7400 titles of e-books from McGraw-Hill, Pearson Education, Elsevier, Tritech, CBS and EBSCO are accessible to the users. Library is also subscribing good number of print magazines and daily newspapers. Press Reader package is being subscribed to access thousands of national and international newspapers and magazines with access of back issues. The library is also the member of DELNET and e Shodh Sindhu consortia.

e-Library Portal with remote access facility provides access to more than 6 Lakh e-resources. It provides the access of variety of e-resources like e-journals, e-books, expert lectures, video tutorials, e-newspapers, e-magazines, and other e-contents. It can be accessed by the registered users 24X7 from anywhere. Mobile App is also available for both Android and iOS users to access e-Library Portal on smart phones

# OFFICE OF DEAN STUDENT WELFARE



# STUDENT'S LIFE AT UNIVERSITY



## BRIDGING THE GAP BETWEEN INDUSTRY AND ACADEMIA


The University has setup Centres of Excellence (CoE) in collaboration with DANFOSS under the theme 'Climate and Energy', Daikin Airconditioning India Pvt. Ltd. on HVAC systems and Godrej and Boyce Manufacturing Company Limited to initiate vocational training activities. The University has also set-up Industry Training Centres in collaboration with Royal Enfield and Bosch India.

These Centres will enable the University to bridge the gap between industry and academia by incorporating global industrial practices and technologies into the academic curriculum and also improve employability and self competency in the students.



# FACILITIES

## AUDITORIUM



The University has constructed an auditorium in 2017 to promote the conduct of International, National and State University events such as conferences, workshops, seminars, meetings, placement programmes and cultural events. The Auditorium was inaugurated by Chief Minister Sh. Manohar Lal on October 26, 2017. The auditorium is well-furnished, air-conditioned and equipped with modern projection and audio systems with access to the internet. The auditorium features fixed traditional theatre style seating with a capacity of more than 200 persons, raised stage, adjustable lighting, sound system, large screen for video and computer presentations. The auditorium is designed in such a way that they ensure a perfect view of the main stage irrespective of the seating location of the audience.

## SHAKUNTALAM MULTIPURPOSE HALL

One of the biggest attractions of the University is Shakuntalam—A multipurpose hall, located in the heart of the University which is designed in adherence to the ultra-modern and eco-friendly specifications. It is extensively utilized as an integral domain of the University and an architecturally beautiful structure on the campus. This huge space has been in use for both sports events as well as for non-sports activities. It provides a well-equipped space suitable for a wide range of activities such as cultural fest, yoga, workshops, exhibitions and poster making sessions. The Multipurpose Hall is also equipped with HVLS fan which keeps the space cool and comfortable.



# FACILITIES

## UNIVERSITY HEALTH CENTRE

The University Health Centre is located within the campus, at a close distance from the academic and hostel blocks. It has been upgraded in the year 2017 into a fully air-conditioned Health Centre having one regular and one part time doctor, nurse, pharmacist, clerk/typist, dispensary attendant and a helper attendant. It was inaugurated by social reformer Sh. Indresh Kumar on July 16, 2017.

The Health Centre caters to the needs of all the students and staff, including regular check up and medicines for common ailments. The Health Centre also conducts various investigations such as CBC, MP by Card Method, Typhi Dot, LFT, KFT, LIPID Profile, Blood Group, Widal and ECG.



## MAHARISHI NARAD - CENTRE FOR MEDIA RESEARCH AND PRODUCTION

To cater the learning needs of students of media studies, the University has an advanced Digital Studio in the newly constructed Science Block. The Studio not only provides practical training and exposure to the students but is also an added facility to produce in-house online lectures of the University, besides fetching the consultancy projects in relevant area.

## SARASWATI E-CONTENT DEVELOPMENT CENTRE

The Saraswati e-Content Development Centre, a cutting-edge facility established by the University, aims to elevate e-content creation among faculty members. This dedicated Lecture Capturing Facility (LCF) empowers educators to produce top-tier recordings of lectures, accommodating diverse learning preferences and styles, from audio-based captures to comprehensive video presentations. The Vice-Chancellor, Prof. Sushil Kumar Tomar, officially inaugurated the facility on March 18, 2024, in the esteemed presence of Prof. Bhagwan Singh, former Registrar of Chaudhary Bansi Lal University, marking a pivotal moment in the University's commitment to advancing educational resources.



# STUDENT ACTIVITY CENTRE (SHRI KRISHNA BHAWAN)



Shri Krishna Bhawan (Student Activity Centre) is a building with centralized student-centric activities and facilities. The building, which is named after Lord Shri Krishna, encompasses a cafeteria and mess facilities for students, along with spaces designated for student activities under the office of Dean Student Welfare through various student clubs. Serving as a centralized hub, Shri Krishna Bhawan facilitates student registration, scholarships, and various welfare programs under the Academics Section and its Registration and Scholarship Branch, ensuring seamless accessibility and convenience for all University students.

## COMMON FACILITIES

The University prioritizes the well-being of both residential and non-residential students, as well as faculty members, by offering a plethora of amenities to enrich their lives. Among these, the Vita Milk Booth and Mother Dairy ensure that students receive nutritious and delicious dairy products conveniently within the campus, promoting their health and vitality. Moreover, with the presence of the Indian Overseas Bank, Indian Post Office, Stationery Shop, and ATMs on its campus, the University endeavours to provide comprehensive support services, fostering a conducive environment for learning and growth.



# TOWARDS NEP-2020

J.C. Bose University of Science and Technology, YMCA, Faridabad has taken several initiatives for the implementation of the National Education Policy 2020. These initiatives include:

- The implementation of the Choice Based Credit System in all UG and PG programs since 2016.
- Encouraging students to enroll/register themselves on the Academic Bank of Credit Portal, with a significant number of students already registered.
- Establishing four Centers of Excellence and a Technology Business Incubator to provide a supportive platform for students to realize their start-up dreams. The University is also considering establishing new Centers of Excellence on Artificial Intelligence and Machine Learning, and on Bioprospecting and Bioprocessing.
- Inculcating ethical values among students through courses on Bhadwad Gita, Swami Vivekananda's Thoughts, The Constitution of India, Human Ethics and Professional Values, Yoga, and Naturopathy. The University also organizes events to enhance problem-solving skills and creative thinking amongst students.
- Integrating vocational programs into mainstream education with various vocational courses under the Community College of Skill Development.
- Preparing a scheme of various disciplines incorporating a Multiple Entry-Exit system at the University level, where it is compulsory for students to choose at least one vocational subject. The University is also exploring the possibilities of bringing flexibility in Master's programs, including 1 Year programs - for those who have completed the 4-year Bachelor's degree; 2-year programs for those who have completed the 3-year Bachelor's degree, and Integrated 5-year Bachelor's/Master's programs.
- Offering courses of Multidisciplinary education under the Faculty of Interdisciplinary Studies and Research and other faculties.
- Preparing a draft of Institutional Development Plan to enhance development in all directions, such as the development of a new campus, concept of Open Library, Centre(s) of Excellences, 24-Hours Reading Hall, MoUs with nearby reputed research institutes such as "IOCL, RCB, NCCB" etc. The University is inclined more towards research and is emerging as a "Research-Intensive University."
- Conducting syllabus workshops, modifying curriculums as per the latest technology in emerging areas, following AICTE guidelines in each and every Engineering, Management program, Sciences & Humanity offering Ph.D. programs in most relevant fields, conducting skill-based training, industrial/research laboratories visits, expert lectures on emerging areas, and teaching environmental education in every program.
- Establishing a "University Computer Centre & Digital Affairs Cell" responsible for establishing IT infrastructure and carrying out the digitization of all processes in the University. The University has developed/deployed various software, including Digital Learning Management System (DLMS), ERP Portal, Faculty Information Management System (FIMS), Feedback System, COVID-Helpdesk, Admission portal, and University Website, etc.
- Broadening the education frontiers for international students in all university courses, including science and journalism, and offering 15% supplementary seats under the foreign category in the field of Computer Engineering, and 5% seats are reserved for international students in all courses offered by the Faculty of Sciences and Faculty of Management Studies.
- Establishing sustainable partnerships with various internationally prestigious Universities and having faculty members of different departments as members of diverse International professional societies (IEEE/IET/IAENG, etc.) to enhance student and faculty experience at the international level.

# EMPLOYMENT AND TRAINING OFFICE



**Subject: Regarding issuing Income Certificates through SARAL portal.**

Sir/Madam,

I am directed to invite your attention to provisions of the *Haryana Parivar Pehchan Act, 2021 (20 of 2021)* which provides for the assignment of the Parivar Pehchan Number (PPN) as a unique identifier number to each family. The database namely Family Information Data Repository (FIDR) contains PPN alongwith corresponding information generally required for determining eligibility for, or the provision of any scheme, service, subsidy or benefit provided/implemented by or on behalf of the State Government/any Government agency/local authority. State Government has been empowered under Section 8 of the Act to prescribe Parivar Pehchan Number (PPN) as a requirement for the purpose of determining above mentioned eligibility or provision. The verified information linked with PPN available in Family Information Data Repository (FIDR) has now made it feasible to issue Income Certificates across the counter through SARAL portal.

3. Keeping in view the above, Government has decided to issue instructions regarding issuance of Income Certificates, in suppression of previous instructions, if any, as under:-

**(i) Portal for issuance of Income Certificate.—**

Income Certificate shall be issued to eligible residents of Haryana on provision of PPN through the SARAL portal (<https://saralharyana.gov.in/>) facsimile signed by ADC-cum-DCRIO (Additional Deputy Commissioner cum District Citizen Resources Information Officer).

These certificates will be issued on the basis of verified data on income contained in FIDR.

**(ii) Person who is entitled to obtain Income Certificate.—**

A person who is a resident of State of Haryana shall be entitled to obtain Income Certificate on provision of PPN and having income verified in FIDR.

**(iii) Verification of Income.—**

The income shall be verified on the basis of the verified data contained in the Family Information Data Repository (FIDR) in accordance with the provisions of the Haryana Parivar Pehchan Act, 2021 and notifications issued thereunder.

**(iv) Competent Authorities for issuance of Income Certificate.—**

Income certificates shall be issued on provision of PPN through SARAL portal (<https://saralharyana.gov.in/>) to eligible residents of Haryana by ADC-cum-DCRIO (Additional Deputy Commissioner -cum- District Citizen Resources Information Officer) under his jurisdiction through his facsimile signature on the certificate.

**(v) Online Service for verification of income based on PPN.—**

Residents seeking to get their income verified in FIDR may visit '<https://meraparivar.haryana.gov.in/ReportGrievance>' portal. Once the request for verification of income is made by the resident on this portal, designated LC will verify and mark the same as verified in the FIDR for the resident.

**(vi) Validity of an Income Certificate.—**

- (i) An Income Certificate once issued (in its standard format) shall be valid for the current financial year, i.e till coming 31<sup>st</sup> March (included) from the date of issuance of the certificate.
- (ii) An Income Certificate may become invalid at any time during the financial year, if after due process, it has been concluded that the income was incorrectly mentioned on the certificate or wrongly verified in the FIDR, due to any reason whatsoever.

**(vii) Grievance Redressal and Correction Process.—**

If an applicant is not in agreement with his income contained in the FIDR, then he/she may lodge his/her grievance for re-verification on the Grievance Module of the PPN portal (<https://meraparivar.haryana.gov.in/ReportGrievance>). The grievances will be dealt with as per the mechanism separately notified by Haryana Parivar Pehchan Authority under the provisions of the Haryana Parivar Pehchan Act, 2021.

**(viii) General Terms and Conditions.—**

- (a) The Income Certificate is usable without any restriction wherever it is accepted (i.e., subject to the criteria laid down by the entity accepting the certificate) and hence no usage/applicability restrictions shall be mentioned on the certificate.
- (b) From the effective date of this order, only the Income Certificates issued through SARAL portal in the format prescribed by the Citizen Resources Information Department, based on PPN and corresponding verified data contained in the FIDR shall be valid Income Certificates.
- (c) An Income Certificate obtained by means of any fraud, misrepresentation or concealment of facts or by any other illegal means shall be declared as invalid and the benefit availed by the candidate/applicant shall be withdrawn and legal action including criminal proceedings will be initiated against the applicant for misrepresenting the facts and playing fraud, as well as against the officials/authorized persons for incorrect/ wrong verification by collusion or otherwise. In such an event, the income shall


be marked as NOT VERIFIED in the FIDR.

- (d) Mere issuance of an Income Certificate does not entitle a person holding such certificate to any benefit that may be admissible under various Government schemes implemented from time to time. Hence, it is important that the authority concerned examines the applicant's entitlement to any specific benefit in accordance with the instructions on the subject at any given point of time. Other eligibility criteria for a particular scheme shall be addressed separately by the authority extending such benefit.
- (e) All Haryana Government organisations (including Departments, Educational Institutions, Boards, Corporations and Societies) are required to accept the Income Certificate in its standard format prescribed by the Citizen Resources Information Department from time to time.
- (f) Any Government organisation accepting physical copy of the income Certificate for the purpose of any scheme, benefit etc. may check the real-time status of the verified income of the person to whom the certificate pertains, on the PPP portal.

4. No Government Department of Haryana shall obligate any resident of the State to submit income related proof documents if he/she provides PPN and his/her income is marked as verified in Family Information Data Repository (FIDR).

I am directed to invite your attention to Government instructions issued vide No. 22/10/2013-1GS-III, dated 15.07.2014 and thereafter regarding rate(s) of reservation in Govt. jobs and to say that in compliance of the judgement dated 01.08.2024 of the Hon'ble Supreme Court in the case titled "State of Punjab v/s Davinder Singh (CA No. 2317 of 2011) with regard to sub-classification and adequacy of representation, the matter was referred to the Haryana State Commission for Scheduled Castes for examination and to send their recommendations to address intra-community disparities and to ensure a fair and equitable distribution of reservation benefits. The Commission submitted their report on 16<sup>th</sup> August, 2024 prepared on the basis of analysis of the data received from various sources including different Departments and of the demands, representations and review of literature related to the subject. The recommendations of the Commission regarding classification of Scheduled Castes reservation in Govt. jobs were considered by the State Government. After the approval of Council of Ministers, it has been decided that—

- (i) For the purpose of reservation in services, the Scheduled Castes in Haryana will be sub-categorized in two categories i.e. Deprived Scheduled Castes (DSC) and Other Scheduled Castes (OSC).
- (ii) List of Deprived Scheduled Castes and Other Scheduled Castes has been enclosed at **Annexure-A** of these instructions.
- (iii) Within the existing 20% quota reserved for Scheduled Castes in direct recruitment to Govt. jobs, one-half of the posts will be reserved for candidates of Deprived Scheduled Castes. If and only if suitable candidates of Deprived Scheduled Castes are not available, then suitable candidates of Other Scheduled Castes may be recruited against the balance vacant posts.
- (iv) Similarly, one-half of the quota reserved for Scheduled Castes shall be reserved for candidates belonging to Other Scheduled Castes. If and only if suitable candidates of Other Scheduled Castes are not available, then suitable candidates of Deprived Scheduled Castes may be recruited against the balance vacant posts.
- (v) The combined merit list of the candidates belonging to Deprived Scheduled Castes and Other Scheduled Castes selected/recommended by the Recruiting Agency will

be prepared and inter-se seniority of such candidates will also be fixed on the basis of merit.

- (vi) It will not be necessary to fix the roster points separately for each of the sub-categories within the present roster system.
- (vii) If on a particular occasion the total number of vacant posts (cadre wise) meant for Scheduled Castes is odd, say 9, then 5 of them will go to Deprived Scheduled Castes and 4 posts to Other Scheduled Castes. On the next such occasion, however, the position would be reversed, i.e. 4 of them will go to Deprived Scheduled Castes and 5 posts to Other Scheduled Castes.
- (viii) After the issue of these instructions, the first vacant post reserved for Scheduled Castes will be allocated to Deprived Scheduled Castes without any change in the roster point already maintained by the Department.

2. These instructions will be applicable with immediate effect and Annexure-B of instructions bearing No. 22/10/2013-1GS-III, dated 15.07.2014 in which the list of castes which are to be treated as Scheduled Castes in Haryana State has been specified for the purpose of reservation in jobs under Government/Government Undertakings and Local Bodies as well as for admission in Government/Government aided educational/technical professional institutions, will be deemed to have been replaced with the Annexure-A of these instructions.

## ANNEXURE - XX

### POLICY FOR PROVIDING SUPPORT BY THE UNIVERSITY TO PURSUE HIGHER EDUCATION TO THE ABANDONED, SURRENDERED AND ORPHAN CHILDREN.

#### **Objective:**

The aim of this Policy is to provide support by the University to pursue Higher Education including Technical Education, Skill Development to the Abandoned, Surrendered and Orphan Children.

#### **Definitions under the Policy:**

- Abandoned:** Abandoned under this Policy means a child found abandoned whose parents, guardians, relatives could not be traced despite making due inquiry and admitted to the Child Care Institution before the age of 5 years and declared abandoned by the Child Welfare Committee (as per Juvenile Justice Act, 2000/2015) or as per the rules prevailing at the time and has completed the age of 18 years while living in Child Care Institutions.
- Surrendered Child:** Surrendered child under this policy means a child who is relinquished by the parents or guardian, on account of physical, emotional and social factors beyond their control and admitted to the Child care Institution before the age of 01 years and declared as surrendered by the Child Welfare Committee after due inquiry (as per Juvenile Justice Act, 2000/2015) or as per the rules prevailing at that time and has completed the age of 18 years while living in Child Care Institutions.
- Orphan Child:** Orphan child under this policy means a child, who have lost their parents (both father & mother) and is without biological or adoptive parents or legal guardian or whose legal guardian is not willing to take or capable of taking care of the child (as per section 2 (42) of JJ Act, 2015) and having the family income (including guardian, if any) less than Rs.2.00 Lakh Per Annum from all sources.

#### **Eligibility & Benefits under the Policy**

- One seat in all UG/PG/ other programme of UTD of this University will be reserve for Abandoned / Surrender / Orphan Children.
- The programmes which required AICTE Approval, the seat will be filled under EWS Category and if same is lying vacant or no application has been received, then seat will be merged in EWS Category. For other programmes except AICTE approved, one seat reserved as supernumerary seat and if remain vacant will not be filled / merged in any other category, as per the provisions of HSTES.
- The student covered under this policy will be provided 100% free education (all fees including hostel charges) after verifying all the document as per the guidelines of policy. The applicants, who have applied for admission under these categories, may bear application form charges, which will be reimbursable after verification.
- Criteria for admissions under this policy:-
  - Abandoned and Surrendered Children upto to the age of 25 years who were admitted to the Child Care Institutions before the age of 05 year (as Abandoned) and before the age of 01 year (as Surrendered) and have completed the age of 18 years while living in Child Care Institution
  - Orphan Children, who have lost their parents (both father & mother) and is without biological or adoptive parents or legal guardian or whose legal guardian is not willing to take or capable of taking care of the child and having the family income (including guardian, if any) less than Rs.2.00 Lakh Per Annum from all sources.

Both (a) and (b) will be provided Free Higher Education including Technical Education alongwith hostel facilities in the University. However, minimum eligibility criteria of respective courses as per University Information Brochure notified time to time, must be fulfilled by the applicants.

- The applicant must produce a certificate issued by the Competent Authority/ Body i.e. Concerned District Programme Officer.
- The admissions shall be made under this policy purely on merit basis.
- This policy is only for Haryana Residents applicants.
- The expenditure incurred for admission and continuance of study of such students including hostel expenditure in the University will be met from the Dean Student Welfare fund or some outside NGO/Agencies.

*Copy of letter No. 62/17/95-6 GSI Dated, Chandigarh, the 3<sup>rd</sup> October, 1996 received from the Chief Secretary to Government Haryana addressed to All Heads of Departments, Commissioners Ambala, Rohtak, Gurgaon and Hisar Divisions, All Deputy Commissioners and all Sub Divisional Officers (Civil) in Haryana, The Registrar, Punjab and Haryana High Court and all District and Session Judges in Haryana.*

**Subject: "Bonafide residents of Haryana - Guidelines regarding".**

I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate: -

- (i) Candidates, who have passed the examination qualifying there for selection in an institution from a school/college in Haryana.
- (ii) Children/Wards (if parents are not living) / Dependents: -
  - (a) of the regular employees of Haryana State posted in or outside Haryana State or working on deputation;
  - (b) of the regular employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
  - (c) of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;
- (iii) Children/wards (if parents not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
- (iv) Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana;
- (v) Children/Wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
- (vi) The wives of such persons who are bona fide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;
- (vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:
  - (a) Citizen of India;
  - (b) Produce an affidavit to the effect that they or their children/wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.

2. All candidates claiming to be bona fide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub-Divisional Officer (Civil) of the District/Sub-Divisions to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/ Wards/Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/ Department of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.

3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana, may not be required to produce Resident Certificate, if they have passed the examination from a school/college situated in Haryana. For this purpose, a certificate of the Principal/Headmaster from concerned institution where the children/wards studied last should be considered sufficient. The Principal/Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
