

Sub: Offer of appointment as Ombudsperson in the University.

Sir,

We are pleased to inform you that the J.C.Bose University of Science & Technology, YMCA, Faridabad is appointed you as Ombudsperson in the University for Redressal of Grievances of students under the UGC (Redress of Grievances of Students) Regulations 2019, as per guidelines notified by the AICTE vide Notification No. 1-101/PGRC/AICTE/Regulation/2019, on the following terms and conditions:

(A) TERMS & CONDITIONS OF APPOINTMENT

1. You will be the functionary designated as Ombudsperson to hear and decide on appeals preferred against the decisions of the Student Grievance Redressal Committee (SGRC) of the University.
2. You shall not, at the time of appointment, during one year before appointment or in the course of your tenure as Ombudsperson, be in a conflict of interest with the Institution where your personal relationship, professional affiliation or financial interest may compromise or reasonably appear to compromise, the independence of judgment toward the Institution.
3. The tenure of appointment shall be for a period of three year or until you attain the age of 70 years, whichever is earlier, from the date of assuming office and shall be eligible for re-appointment for another one term for the University.
4. For conduct of hearing you will be paid a sitting fee @ Rs. 5000/- (Rupees Five Thousand only) per diem and will, in addition, be eligible for reimbursement of the expenditure incurred on conveyance.
5. The University reserves the right to remove the Ombudsperson from office, on charge of proven misconduct or misbehavior as defined under these Regulation, after giving reasonable opportunity for hearing.

(B) FUNCTIONS OF OMBUDPERSON

1. The Ombudsperson shall hear appeals from an aggrieved student(s) only after the student has availed all other remedies provided under these Regulations.
2. While issues of malpractices in the conduct of examination or in the process of evaluation may be referred to the Ombudsperson, no appeal or application for revaluation or re-totaling of answer sheets from an examination, shall be entertained by the Ombudsperson unless specific irregularity materially affecting the outcome of specific instance of discrimination is indicated.
3. The Ombudsperson may avail assistance of any person, as amicus curiae, for hearing complaints of alleged discrimination.
4. The Ombudsperson shall make all efforts to resolve the grievances within a period of 30 days of receiving the appeal from the aggrieved student(s).

We shall be thankful, if the acceptance of appointment offer is conveyed to the University as early as possible.

- (i) The term of the committee members and special invitee shall be two years.
- (ii) The quorum for the meeting including the chairperson but excluding the special invitee shall be three.
- (iii) In considering the grievance before it, the SGRC shall follow principles of natural.
- (iv) The SGRC shall send its reports with recommendations, if any to the Vice Chancellor and copy thereof to the aggrieved student, with a period of 15 days from the date for receipt of the complaint.
- (v) Any student aggrieved by decision of the Student Grievance Redressal Committee (SGRC) may prefer an appeal to the ombudsperson, within period of fifteen day from the date of receipt of such decision.
