All Chairpersons of UTDs and Principals of affiliated Institutions are requested to take necessary action for enrolment of students in MOOCs on SWAYAM Portal for the forthcoming semester as per the "Credit Transfer/Mobility Policy of online courses" approved in the 17th Academic Council held on 11.6.19 and amended in 20th Academic Council held on 31.8.2020 (<https://tinyurl.com/creditsymca>) and "notification for modalities of MOOCs for non-engineering UG courses under NEP" approved in 28<sup>th</sup> Academic Council held on 10.10.2023 (<http://tinyurl.com/UG-NEP>). Based on the modalities, a "Credit Transfer/Mobility Policy of MOOCs for the 4-year Undergraduate Program (Non-Engineering) under National Education Policy (NEP)-2020" was approved at the 30th meeting of the Academic Council on 09.01.2025 ([https://jcboseust.ac.in/assets/files/NEP\\_UG\\_2023-24\\_Credit\\_Transfer\\_Policy\\_for\\_MOOCs\\_3.pdf](https://jcboseust.ac.in/assets/files/NEP_UG_2023-24_Credit_Transfer_Policy_for_MOOCs_3.pdf)).

All concerned are requested to ensure the enrolment of the students as per the policy documents keeping in view the course commencements provided on SWAYAM Portal.

Credit transfer of MOOCs completed by students in each of the semester must be processed at the end of semester on the ERP of University.
