➤ **GENERAL INSTRUCTIONS:**

All the candidates are advised to read and follow the instructions before reporting in the counseling:

1. The candidates must fulfill the eligibility criteria of the course:

**Eligibility Criteria:**

**B.Sc. with Biological Sciences with at least 50% marks in aggregate (45% for SC/ST candidates of Haryana only) or equivalent CGPA from any recognized Univ./Institute.**

2. Candidate must have to **attend the counseling physically** and also to present themselves in person before the admission committee for the allotment of seat. **Physical attendance of the candidate at the counseling is mandatory.**

3. **Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.**

4. If a candidate arrives or reports late for counseling, they will only be eligible for the available seats at their turn after the verification of documents.

5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.

6. Admissions must be within the sanctioned intake of the respective program and in accordance with the State Government Reservation Policy. **(Please refer University Information Brochure 2025-26 and the Seat Matrix notified vide number 10/10/ 2025/Acad-2265 dated 23.06.2025).**

7. It is mandatory for the candidate to pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed. **However, no fee will be charged from Schedule Caste (SC) candidates who are eligible under the Post Matric Scholarship Scheme for SC students.**

Detailed instructions in this regard will be notified separately.

8. Only verified/eligible candidates should be allowed to submit the admission fee of the respective program as mentioned in the University Brochure 2025-26.
9. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through **PPP (Parivar Pehchaan Patra)** as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. **All candidates seeking admission are advised to get updated and verified PPP ID.**
10. Candidates belonging to **SC, SC-D, BC-A, and BC-B** categories must submit relevant category certificates issued by the competent authority. Parents of BC candidates (Block A & B) must submit an income certificate showing their **gross annual income below Rs. 8 lakh and an affidavit regarding exclusion of Creamy Layer** as per Annexure-VI of Information Brochure 2025-26 of the University. Annual family income should be verified from their PPP ID. For the criteria for exclusion of persons within the Backward Classes as Creamy Layer, please refer to **Haryana Government Gazette No.107-2024/Ext. dated 16-Jul-2024.** **NOTE:** The income certificate should be of the current financial year 2025-26.
11. For admissions under the Economically Weaker Section (EWS) category, candidates must mandatorily provide the **EWS Income & Asset Certificate showing income below Rs.6 lakh**, issued by the Competent Authority of Haryana State only. A Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the EWS category if the candidate qualified their last qualifying exam from another state. However, the family income of the candidate should be matched & verified from his/her PPP ID. In the event of non-availability of students in this category, the seat shall not be given to any other category of candidates.
12. For admissions under the **Tuition Fee Waiver (TFW) category**, the candidate must provide an Income certificate issued by the Competent Authority of Haryana State, stating an income of less than Rs.8 lakh from all sources and verified through their PPP ID. Additionally, a Resident/Domicile Certificate of Haryana is also mandatory to avail the benefits of the TFW category if the candidate qualified their last qualifying exam from another state. Candidates admitted in this category shall not be allowed to change the institution/program under any circumstances. In the event of non-availability of students in this category, the seat shall not be given to any other category of candidates
13. If a candidate has passed the B.Sc. examination from Haryana state, the resident/domicile certificate is not mandatory for admissions under the HOGC category.
14. To avail the benefit of ROHC Category, candidates must submit their resident/domicile certificate issued by the competent authority of other respected state, if they have not passed their last qualifying exam from other state.

➤ **SGC (Single Girl Child) Candidates:**

- Student claiming SGC Category should be passed their graduation from the University/College situated in Haryana or they should possess the Domicile/Residence Certificate of Haryana State.
- The eligible Single Girl Child required to submit an affidavit on stamp paper worth Rs. 20/- duly attested by 1st Class Magistrate, to be obtained from the parents of the girl child declaring therein that the girl child is only a single child of their family not having any brother/sister.

➤ **Abandoned/Surrendered/Orphan children:**
