(2) Item no. 1: To consider and approve the minutes of BOS which was held on 12 Sept 2011 at 12'o clock.


- a) FOMS has approved the minutes of B.O.S. with a few significant suggestions for the course of Disaster Management.

(3) Item no. 2: To consider the syllabi of Disaster Management.




- (ii) Proper labs such as geographical lab & IT lab must be maintained for successful execution of the course.
- (iii) Practical case studies & Projects should be included in the curriculum.
- (iv) IT experts should be hired to discuss topics like cyber crimes.
- (v) Placement options/ scope for students should be found for the students who are willing to take admission in the course.
- (vi) Some subjects of the course should be optional but some compulsory subjects must be floated for students.
- (vii) Subjects like geo-informatics, cyber terrorism, Information warfare & network security, Environment impact assessment & disaster management, disaster mitigation may be included in the curriculum of Disaster Management.
- (viii) The committee must contact NIDM (National Institute of Disaster Management), Disaster Management Cell (Central Home Ministry) for relevant information regarding the course and its scope for the students.

(3) Item No. 3 : Any other item with the permission of the chair.

The committee constituted for the purpose of framing syllabi of Disaster Management must move to different Universities and gather information and relevant data to start the course in an effective manner.
