Date: 15.10.2024

The BOS meeting was held on 15/10/2024 in the conference room of the Department of Management Studies at 12 noon. At the outset all members of BOS were welcomed. The following items were discussed in the meeting:

Item No. 1

To confirm the minutes of meeting held on 01/05/2024.

The BOS discussed the action taken (annexure I) on previous minutes of meeting held on 01.05.24 and approved the minutes.

Item No. 2

To approve the scheme and syllabi of 3rd year and 4th year BBA of the university running for batch 2023-27 and 2024-28 as per NEP guidelines.

The BOS discussed and approved the scheme and syllabi of 3rd year and 4th year BBA program of the university running for batch 2023-27 and 2024-28. Since the scheme and syllabi of first and second year has already been approved in previous BOS, so, the board suggested to incorporate course objectives in the entire scheme and syllabi in next revision.

Item No. 3

To approve the scheme, syllabi and content of open distance learning BBA program.

The department proposed to initiate BBA in Open and Distance Learning mode. The BOS approved the curriculum for BBA in Open and Distance Learning Program in line with the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) regulations, 2020 and rule and regulations of J C Bose University of Science & Technology, YMCA, Faridabad framed from time to time. The members consented to the view that in some courses the feasibility of the content and delivery of curriculum may be observed keeping in view the nature of the program.

The BOS also resolved that four-year bachelor's degree with Honors will be permitted but Honors with Research shall not be permitted to be offered in line with the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) regulations, 2020.

The BOS further approved the tentative course content/study material of theoretical subjects of first two years of BBA ODL programme subject to revisions from time to time. The BOS also suggested
