➤ GENERAL INSTRUCTIONS:

All the candidates are advised to read and follow the instructions before reporting in the counseling:

1. The candidates must fulfill the eligibility criteria of the course:
Eligibility Criteria: Bachelor's degree (B.Sc. or B.Tech. or equivalent) in any branch of Science / Engineering / Technology / Agriculture with 50% marks in aggregate (45% for SC/ST candidates of Haryana only) from a recognized University/Institute/College.
2. The candidates are required to keep their original certificates/documents/ testimonials with him/her at the time of Manual / Institute Level counseling for verification.
3. Candidate must have to attend the counseling physically and also to present themselves in person before the admission committee for the allotment of seat. **Physical attendance of the candidate at the counseling is mandatory.**
4. Eligibility of the candidate for the admission is subjected to verification and submission of required documents at the time of admission.

5. If a candidate reports late for the document verification during counseling, he/she will be eligible only for the available seats at his/her turn after verification of documents.
6. The caste/reservation/annual income/financial benefits given to the candidates shall be based on verified caste/income data fetched through **PPP (Parivar Pehchaan Patra)** as per the State Government. Any unverified PPP data of the candidate shall lead to their candidature being considered in the general category only. **All candidates seeking admission should be advised to get updated and verified their PPP ID.**
7. Candidates have to deposit the Admission Fee amount of **Rs 36542/-**. The candidate must pay the requisite fee at the time of admission; otherwise, their admission will not be confirmed.
8. Admission Fee can be deposited in the form of a Demand Draft (drawn in favor of "Registrar J.C. Bose UST, YMCA Faridabad") **on the spot** on offering the seat for admission. Payment can also be made by Debit/Credit card with applicable charges. **Cash will not be accepted in any case.** For more details, refer to the University Information Brochure 2025-26 available on the University Website.
9. **For Fresh Applications, the candidates will have to submit the application fee of Rs 1050/- (Rs 525/- for SC/ST candidates of Haryana) as applicable during open/on-spot counseling.**
