4. **For Part Time PhD, the applicant should be an employee of an educational institute/organization/Industry and must produce a 'No Objection Certificate (NOC)' from his/her employer on or before the interview, clearly stating that: (i) The candidate is permitted to pursue studies on a part-time basis. (ii) His/her official duties permit him/her to devote sufficient time for research. (iii) If required, he/she will be relieved from the duty to complete the course work.**

17.12.2021 will be applicable for specifying the criteria for exclusion of persons with backward classes as creamy layer.
