### **Sub: Grant of Merit-Cum-Means Scholarship to B.Tech./MCA/MBA students for the session 2025-26.**


As per policy of this university the **Merit-Cum-Means Scholarship** is admissible to the students of **B.Tech/MCA/MBA** for Haryana residents only as per details given below :-

As per Govt. of Haryana Scheme, 15% of the sanctioned/admitted strength of B.Tech./MCA/MBA course or actual intake whichever is less, are eligible for grant of **Merit-Cum-Means Scholarship** Rs.750/- p.m. The students who have passed their last two semester examinations and secured atleast 7.750 CGPA are eligible for applying this scholarship.

All the students who want to apply for **Merit-Cum-Means Scholarship** may download the application form from **University Website** i.e. "[jchouseust.ac.in](http://jchouseust.ac.in)" & submit the hard copy of the same along with self attested documents in Scholarship Branch from 10:00 a.m. to 1:00 p.m. upto **21.11.2025** positively. The students may note it carefully that no application form for grant of above scholarship would be entertained after by **21.11.2025**.

### **ELIGIBILITY CONDITIONS:**

1. The student must have 80% attendance for above scholarship in all semesters.
2. In case a student fails to secure SGPA 7.750 in previous semester, his/her scholarship would be discontinued and in case he/she improve in the subsequent semester, his/her scholarship would be restored.
3. The **Merit-Cum-Means Scholarship** will be admissible to only those students whose parent income is not more than Rs.4.5 lacs per annum.
4. The conduct of such students, who are granted the above scholarship, should be good and they should not indulge themselves in any in-disciplinary activities. If any student is found indulged in such activities, his/her scholarship would be discontinued.
5. A student would be eligible for the above scholarship only, if he/she is not getting any other scholarship or financial help from any other quarter.
