Such interested applicants are advised to report on July 27, 2021 at 9:00 am in the multimedia center of the University for Interview & Presentation on teaching skills (5 minute ppt), along with all original documents/testimonials for verification in support of his/her eligibility. No applicant will be allowed to appear in the Interview without verifying the eligibility.
