The duration of this test will be 120 minutes. It will comprise of MCQs and/or subjective questions, out of syllabus already notified along with the advertisement No. 5/2019. There will be no negative marking for a wrong answer. The minimum qualifying marks shall be 40%. The test will be held in English medium only. The Question Paper will comprise of three sections - General Aptitude (30 marks), Office Procedures (30 marks) and Computer Appreciation & Applications (30 marks).

Further, it is clarified that all such qualified applicants are being allowed to appear without declaring them eligible. The applicants must satisfy themselves about their eligibility, before appearing in the test. The eligibility as per criteria advertised is subjected to fulfilling the requisite conditions and will be established only for such candidates who qualify this written test. Merely qualifying this test will not make anyone entitle to be considered for final merit list. Please note that no TA/DA would be admissible for appearing in test.
