This written test will be of 90 minutes duration, containing objective and/or subjective questions out of following topics:

Part A: General Knowledge, English Language: Comprehension, Grammar..etc  
Higher Education System: Governance, Policy & Administration

Part B: University Administration: The University Act, Statute & Ordinances Structure, Role & Functions of the University Authorities, Civil Services Rules, General Service conditions & office procedures, Financial Management: Accounts, Budget, Taxation, Audit, role of DDO, Procurement of Goods & Services, Contract Management, RTI Act 2005, Examination regulations, Accreditation

The candidates, who qualify the above test and are eligible as per eligibility criteria mentioned in advertisement, shall be considered for short-listing for the skill test and personal Interview. The list of such candidates, who shall be shortlisted for skill test and Interview, will be displayed on the notice board and website of the University on Aug 30, 2019, along with the schedule of skill test and Interview.

Further, it is clarified that all the applicants are being allowed to appear in the test without declaring them eligible. The candidates must satisfy themselves above their eligibility, before appearing in the test. The eligibility as per criteria advertised is subject to fulfilling the requisite conditions and will be established only for such candidates who qualify this test. Merely qualifying this test will not make anyone entitle to become eligible for further short listing for the skill test/Interview. However, each shortlisted candidate will be required to bring all original documents/testimonials at the time of Interview for verification in support of his/her eligibility.
