The applicants who have claimed such reservation are required to produce the requisite certificate along with Income Certificate issued from the Competent Authority as defined vide State Govt. Notification No. 1389-SW-(1)-206 dated 18.11.2016. The applicants failing to adhere the same will be considered against GENERAL Category posts only.
