
**Subject: Invite applications from Economically Weak/Needy Students for Financial Assistance for the ~~ADD~~ Semester 3<sup>rd</sup> / 5<sup>th</sup> / 7<sup>th</sup> 2022 for the Session 2022-23.**

This is for information of all the students of all the courses who are at present studying in this University that according to the Policy formulated for providing the financial assistance to economically weak/ needy students of this University. As defined in this policy, economically weak/ needy students, those who are unable to afford the course fee due to financial crunch in the family that might have arisen due to:

- Death of parent/sole earning member of the family.
- Critical illness for self/family member incurring exorbitant cost.
- Loss of job/earning of a parent/sole member for a substantial period.
- Any such valid reason

The Financial help will be provided as soft loan (without interest) to the deserving students as recommended by their Chairpersons. After completion of course, as & when he or she will get the job, the concerned students have to repay their loan amount. In this regard, students have to furnish an **Affidavit on Rs.10/- Stamp Paper (duly attested by Notary Public/Oath Commissioner)** along with the application form and other required documents and students may also note it carefully that no application form for grant of this financial help would be entertained after **04.10.2022**.

Accordingly, all such students of this University who consider themselves under any of the above category (not receiving any other Scholarship from any sources) may apply on prescribed form available on University website, i.e. [www.jcboseust.ac.in](http://www.jcboseust.ac.in) to the Chairperson of the concerned Department along with requisite proof to support his/her claim latest by **04.10.2022 upto 5:00 p.m.** After due consideration, the approved claims would be admissible in form of refund of fee to the extent of financial assistance. Such students (5<sup>th</sup>/7<sup>th</sup> Semester) are advised to arrange to deposit their semester fee (as the case may be) as per **fee notice No. Fees/2022-23/4488 dated 12.09.2022 and students of 3<sup>rd</sup> semester will be deposit their semester fee as and when their fee notice will be issued by account department.** The financial assistance of the current semester of all the students will be adjusted afterward.
