After discussion on all agenda items, the Chairman of the Council further suggested following points for improving the academic environment of the University:-

- In any programme/course if admissions are less than 05 in a particular academic year then the work load of that batch should not be considered w.r.t. faculty.
- Duration of theory classes should be of 60 minutes.
- The time table of the classes should be extended between 8:30 a.m. to 5:30 p.m. The time table should be designed in such a way that the first two periods should be preferably of theory classes. Also, the library period should be assigned before or after the lunch interval to widen up the accessibility time of library.
