**Subject:** Fee Notice for the semester period August-2021 to December-2021 for SC Students of 3<sup>rd</sup>, 5<sup>th</sup> & 7<sup>th</sup> Semester of all the courses.

As approved by Competent Authority of the University, the following decision has been taken in respect of semester fee of SC students of all the courses for the semester period August-2021 to December-2021 subject to eligible for Post Matric Scholarship.

The Fee for semester period August-2021 to December 2021 will be deposited by the students in the University Bank Account within 10 days from receipt of their scholarship amount.

The terms & conditions to apply the SC Post Matric Scholarship are given here under :-

1. The student should be resident of Haryana.
2. The annual Income of all family members should not be more than Rs. 2.50 lacs.
3. The Issuing Authority of Income Certificate should be Tehsildar only and issued date should be 1st April, 2021 onwards.
4. The Attendance of the student should not be less than 75% per semester.

Regarding Semester Fee for the period August-2021 to December-2021, the eligible SC student has to submit following documents alongwith filled application (Format enclosed here), **upto 06.09.2021** :-

1. Cheque for amount of Semester fee as per their course in favour of Registrar, J.C. Bose UST, Faridabad.
2. An Affidavit duly attested by Notary Public/Oath Commissioner) on a stamp paper of Rs.10/- Performa of Affidavit is enclosed herewith as **Annexure 'A'**.
3. Application form is enclosed herewith as **Annexure 'B'**.
