Sub: Submission of forms for even semester reappear examinations for Intermediate semester students of Echelon Institute of Technology (EIT), Faridabad

Reference: i) the directions of the Hon'ble High Court of Punjab and Haryana dated Oct 09, 2020 in CM-10505 in CWP-6715-2020 (O&M) on the subject (attached herewith) & ii) Request of students of Echelon Institute of Technology, Faridabad vide CWP-16722-2020 heard by Hon'ble High Court of Punjab and Haryana on Oct 09, 2020

In compliance of the above referred directions of the Hon'ble High Court of Punjab & Haryana received at closing hour on Oct 09, 2020, the examinations forms from Intermediate semester students of Echelon Institute of Technology, Faridabad will be accepted by the University for even semester re-appear examinations w.e.f Oct 12, 2020 till Oct 26, 2020.

2. The Examination web-portal of the University is being enabled to submit all such reappear exam forms with immediate effect and remain active till Oct 26, 2020. All concerned students who are already registered with the University may submit the respective forms through the EIT Faridabad in its login on the web-portal along with applicable fee to be submitted in the Examination Branch. The exam form of any student who is not registered so far may be scanned and submitted through email at conducjcbust@gmail.com or offline along with applicable fee on or before Oct 26, 2020.

3. As per directions of the Hon'ble High Court of Punjab & Haryana referred above, the University will submit the Bank Guarantee as a security against the late fee applicable on submission of these examination forms and the EIT, Faridabad is required to submit the late fee, accordingly.

4. Further, these reappear examinations for EIT students will be scheduled with due consideration of the request and concerns raised by hundreds of EIT students before the Hon'ble High Court of Punjab & Haryana vide CWP-16722-2020 and will be notified accordingly.



The present application has been filed for directing the respondent-University to accept the reappear examination forms of the students admitted in 2017-18, 2018-19 without any late feet/fine, charging only the applicable fees for reappear examination of Rs.1500/- per student per semester of those students who wish to take these exams specifically through web portal by providing the institute due access by opening the same either in the event of the reappear examination being conducted physically or online.

Accordingly, this Court vide order dated 18.3.2020 had directed the respondent-University to accept the application forms of the students of the petitioner.

Learned counsel for the respondent-University has sent document dated 5.10.2020, which is re-produced as under:-

“Sub: Queries/requests about online mode of conduct of re-appear examinations for students of Intermediate semester w.e.f. Oct 12, 2020.


Reference the emails being received containing queries/requests from the students on the subject:

As clarified by the State Govt. vide Memo No.KW-18/79-2020 UNP (4) dated August 31,2020, the concerned students have been promoted to the next semester and the reappear examinations for such students are being held w.e.f. Oct 12, 2020 so as to provide the opportunity to clear/pass the subject(s) in which they had failed/remained absent. It is hereby reiterated that these examinations will be held in offline mode only.

However, the students who are unable to appear in these examinations due to ongoing pandemic may opt not to appear in these examinations. Such students will be provided another opportunity to appear in respective reappear examinations as and when the pandemic subsidies and the circumstances resume to normal.”

It is further stated by learned counsel for the respondent-University that they have requested the petitioner to fill up the forms but they are not doing the same till date and they should submit the same with late fee.

If it is so, the petitioner shall immediately submit their scanned copies of the forms online which the learned counsel for the respondent-University states that he has instructions to submit that the

University shall accept the same. The University shall submit the security towards late fee and in case the said issue is subsequently decided against the University, the University shall be liable to pay the said amount towards late fee.

Meanwhile, the said forms shall be accepted on the normal fee.

It is further clarified that it will be the responsibility of the respondent-University to ensure that proper arrangements are being made to accept the scanned copies of the forms.
